1.	<p><b><u>SATISFACTION OF ALL CITY REQUIREMENTS</u></b>            The Owner agrees, by entering into an agreement to satisfy all requirements, financial and otherwise, of the City of Ottawa, including but not limited to the provision of roads, installation of services and utilities, and drainage.</p>	<b>Ottawa (PRED)</b>

3.	<p><b><u>DESIGNATED VISITOR PARKING SPACES</u></b>            The Owner covenants and agrees that all designated visitor parking spaces, as shown on the approved Site Plan, shall be used for visitor parking only.</p>	<b>Ottawa (PRED)</b>
4.	<p><b><u>FLYING OF FLAGS</u></b>            The Owner shall not prohibit the flying of flags but may regulate them to ensure only that they are displayed in a safe manner and do not interfere with the reasonable use of other units.</p>	<b>Ottawa (PRED)</b>

The Owner acknowledges and agrees that notwithstanding the rights granted to the City under the grant of easement, the Owner remains responsible at all times for the maintenance, inspection, alteration, repair, replacement and reconstruction of the utility in the said lands during their term of use.</p>	
7.	<p><b><u>PERMISSION TO ENTER</u></b>  The Owner shall at all times allow the City to enter the lands with machinery, materials, vehicles and equipment necessary to maintain, inspect, alter and repair the Private Watermains, hydrants and Water Plant located on the lands. The Owner acknowledges and agrees that notwithstanding the rights granted to the City, the Owner remains responsible at all times for the maintenance, inspection, alteration, repair, replacement and reconstruction of the utility in the said lands during the term of use.</p>	Ottawa (PRED)
8.	<p><b><u>UNOBSTRUCTED ACCESS</u></b>  The Owner shall be responsible for providing free and unobstructed access to the Works, as required, including keeping the hydrants free at all times from ice, snow or other material so that it will be readily accessible to the City at all times.</p>	Ottawa (PRED)
9.	<p><b><u>MAINTENANCE OF PRIVATE SERVICES</u></b>  The Owner acknowledges and agrees that the Water Plant and sewer service within the lands is a private system, including Private Services and sewer services and appurtenances, and the Owner acknowledges and agrees that it is responsible for the operation, maintenance and/or replacement, in perpetuity, of the Private Services and sewer system, including the Private Watermains, private hydrants, private sanitary and storm sewer infrastructure (collectively the "private system") which are located on the lands and that the Owner will retain copies of all the associated Work and maintenance contracts, and make said contracts available for inspection upon demand by the City. Further, the Owner acknowledges and agrees to have a Professional Engineer, licensed in the Province of Ontario, conduct regular inspections of the water system and sewer system, which includes a leak detection survey at least every five (5) years and a video of the sanitary sewer system to check for major water infiltration into the private system. Copies of the inspection reports and videos shall be provided to the General Manager, Infrastructure and Water Services and Fire Services. The Owner further acknowledges and agrees that as part of the Owner's ongoing maintenance responsibility for the private system, repairs to the system must be completed immediately to correct any deficiencies which contribute to water loss or leakage or infiltration within the private system. Any deficiencies shall be immediately reported to the City. The Owner acknowledges and agrees to notify the General Manager, Infrastructure and Water Services when such repairs have been completed.</p>	Ottawa (PRED)

17.	<p><b><u>PRIOR AGREEMENTS</u></b></p> <p>The Owner, for itself and its heirs, executors, administrators, successors and assigns, for valuable consideration which is hereby acknowledged, acknowledges and agrees to be bound by all of the terms and conditions of the Private Road Agreement registered on <u>2022 07 29</u> as Instrument No. <u>OC 2519452</u> (the “Private Road Agreement”). The Owner further agrees to include a condition in all agreements of purchase and sale of the Subject Property, or any part thereof, requiring that all subsequent owners of condominium units and the Condominium Corporation assume and accept the obligations and responsibilities under the Private Road Agreement, which covenant shall run with the lands. The said condition shall be substantially similar to the following:</p> <p style="padding-left: 40px;">“The Purchaser for himself/herself, his/her heirs, executors, administrators, successors, and assigns acknowledges and assumes the obligations and responsibilities of the Purchaser under the <u>Private Road Agreement</u>, in common with others who may be parties to the said agreement(s).”</p> <p style="padding-left: 40px;">“The Purchaser covenants with the Vendor that the above clause shall be included in all subsequent agreements of purchase and sale for the lands described herein, which covenant shall run with the said lands.”</p>
