The CITY OF OTTAWA's conditions applying to the Final Approval for registration of Common Elements Condominium No. 1 as shown on "Draft Plan of Common Elements Condominium of Part of Block 343, Plan 4M-1619, prepared by Annis, O'Sullivan, Vollebekk Ltd." Tamarack (Fernbank) Corporation's (D07-04-23-0002) for 585 Bobolink Ridge are as follows:

SATISFACTION OF ALL CITY REQUIREMENTS  The Owner agrees, by entering into an agreement to satisfy all requirements, financial and otherwise, of the City of Ottawa, including but not limited to, the phasing of the plan for registration as Common Elements Condominium No.1, the provision of roads, installation of services and utilities, and drainage. SERVICING EASEMENT The Owner acknowledges and agrees that an easement shall be granted in favour of the owners of the residential units located within the lands legally described as Parts 1-38, 73 and 76-77 on Plan 4R-36285, municipally known as 585 Bobolink – Phase 2 (Common Elements Condominium No. 2) and associated with Plan of Condominium File No. D07-04-25-0007 to permit access to the shared Private Services and sewer system including the Private Watermains, private hydrants, private sanitary and storm sewer infrastructure (collectively the "private system") with respect to the lands legally described as Part 75 on Plan 4R-36285 and Parts 1-4 on Plan 4R-37180. PRIVATE WAY ACCESS EASEMENT  The Owner acknowledges and agrees that an easement shall be granted in favour of the owners of the residential units located within the lands legally described as Parts 1-38, 73 and 76-77 on Plan 4R-36285, municipally known as 585 Bobolink — Phase 2 (Common Elements Condominium No. 2) and associated with Plan of Condominium File No. D07-04-25-0007 to permit access to the shared private way known as Rawah Private and legally described as Parts 1 and 3 on Plan 4R-37180. MAINTENANCE OF PRIVATE SERVICES  The Owner acknowledges and agrees that the Water Plant and sewer service within the lands is a private system including Private Services and sewer services and appurtenances, and the Owner acknowledges and agrees that it is responsible for the operation, maintenance and/or replacement of the Private Services and sewer system including the Private Watermains, private hydrants, private sanitary and storm sewer infrastructure (collectively the "private system") which are located on the lands and that the Owner will retain copies of all the associated Work and maintenance contracts, and make said contracts available for inspection upon demand by the City. The Owner further acknowledges and agrees that as part of the Owner's ongoing maintenance responsibility for the private system, repairs to the system must be completed immediately to correct any deficiencies which contribute to water loss or leakage or infiltration within the private system. Any deficiencies shall be immediately reported to the owner of the infrastructure affected. ACCESS EASEMENT TO CITY  Through the Condominium Declaration the Owner shall grant to the City a blanket easement over Part 74 on Plan 4R-36285 with the right and licence of free, uninterrupted, unimpeded and unobstructed access to the City to enter on and to pass at any and all times, on, over, along and upon said lands with or without vehicles, supplies, machinery and equipment for all purposes necessary for access, including but not limited to curb-side garbage collection and emergency vehicles, including, but not limited to, the use, testing and operation of the private hydrants. The Owner acknowledges and agrees that notwithstanding the rights granted to the City under this grant of easement, the Owner remains responsible at all times for the maintenance of the said lands during their term of use. 	and assigns, for valuable consideration which is hereby acknowledged, acknowledges and agrees to be bound by all of the terms and conditions of the Plan of Subdivision approval D07-16-15-0012 and the Subdivision Agreement registered as Instrument OC2083825. The Owner further agrees to include a condition in all agreements of purchase and sale of the Subject Property, or any part thereof, requiring that all subsequent owners of condominium units and the Condominium Corporation assume and accept the obligations and responsibilities under the Subdivision Agreement, which covenant shall run with the lands. The said condition shall be substantially similar to the following:
