- The owner shall make reference to the approved City of Ottawa plan number 17491.
- A Water Permit will be required for the proposed water works associated with the proposed development. The owner shall pay the cost of materials supplied by the City of Ottawa estimated at \$4,403.00, exclusive of excavation, backfilling and

reinstatement. The statement amount is adjustable upon the project's completion. The charges are in accordance with the Regulatory Code and are subject to revisions annually, effective April 1, 2014. Please note that requests for connections greater than 5.5m in length must be made a minimum of seven (7) days in advance.
