Dear Mr. Pollock:

This office has reviewed the above-mentioned report, which has been submitted to this ministry as a condition of licensing in accordance with Part VI of the Ontario Heritage Act, R.S.O. 1990, c 0.18.¹ This review has been carried out in order to determine whether the licensed professional consultant archaeologist has met the terms and conditions of their licence, that the licensee assessed the property and documented archaeological resources using a process that accords with the 2011 Standards and Guidelines for Consultant Archaeologists set by the ministry, and that the archaeological fieldwork and report recommendations are consistent with the conservation, protection and preservation of the cultural heritage of Ontario.

The report documents the assessment/mitigation of the study area as depicted in Map 13 and Map 14 of the above titled report and recommends the following:

- 1) The cultural heritage value or interest of the 788 March Road site (BiFx-22) has been sufficiently documented with the Stage 2 fieldwork conducted to date.
- 2) There are no further concerns for unlicensed impacts to archaeological sites within the study area, as presently defined (see Map 2), and no further archaeological assessment is required.
- 3) Outstanding concerns for impacts to archaeological resources remain for the portions of the subject property lying within the 30 metre setback from Shirley's Brook. The proponent should ensure that 'no-go' instructions regarding the setback lands are issued to construction crews in advance of the initiation of development-related activities on the property. In the event of proposed future impacts within the setback lands, additional archaeological assessment will be required.
- 4) Any future archaeological assessment should be undertaken by a licensed consultant archaeologist, in compliance with Standards and Guidelines for Consultant Archaeologists (MTCS 2011).

Based on the information contained in the report, the ministry is satisfied that the fieldwork and reporting for

the archaeological assessment are consistent with the ministry's 2011 Standards and Guidelines for Consultant Archaeologists and the terms and conditions for archaeological licences. This report has been entered into the Ontario Public Register of Archaeological Reports. Please note that the ministry makes no representation or warranty as to the completeness, accuracy or quality of reports in the register.
