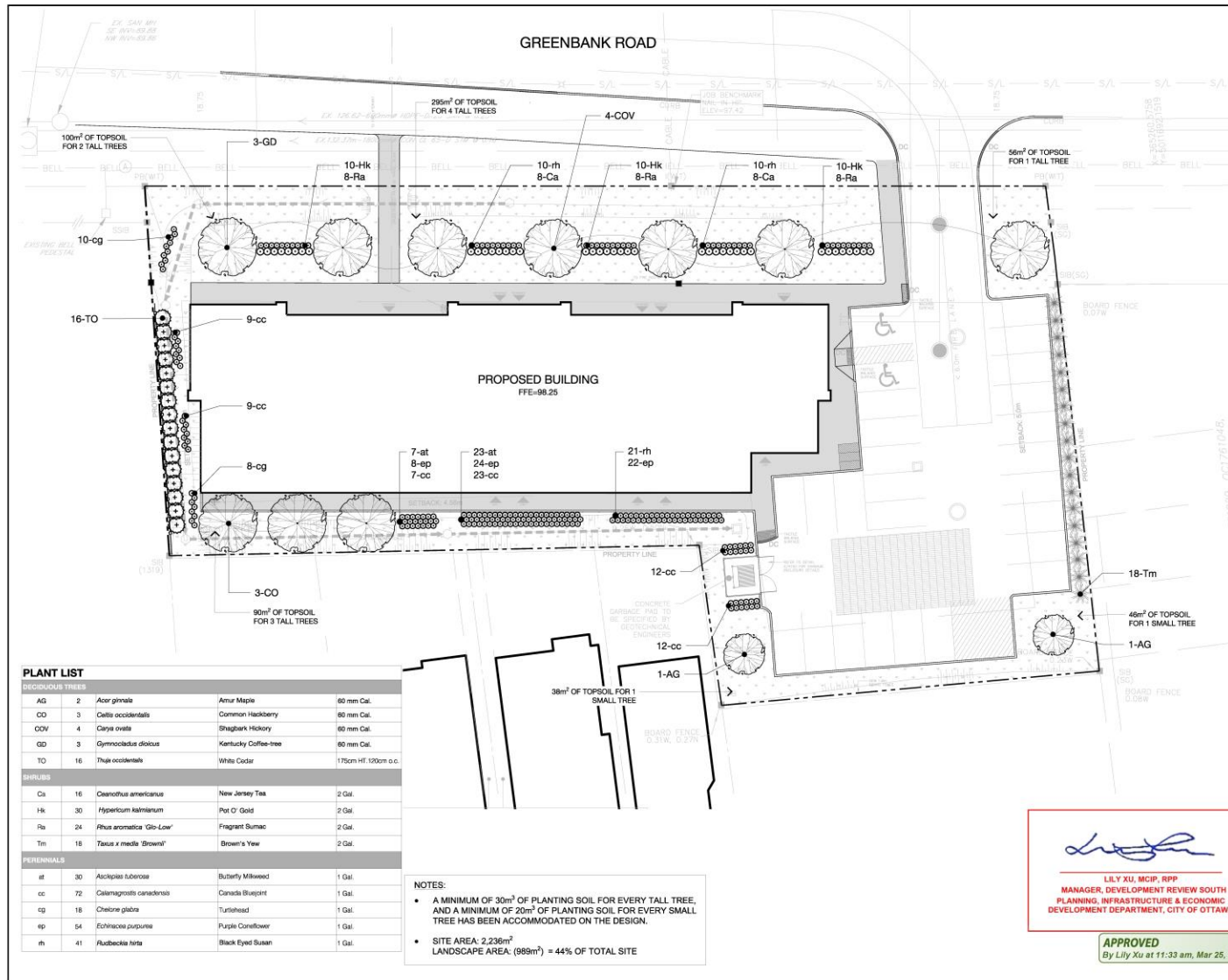




GENERAL NOTES

- CONTRACTOR SHALL CHECK AND VERIFY ALL DIMENSIONS ON SITE AND REPORT ANY DISCREPANCIES, OMISSIONS, OR ERRORS TO THE ARCHITECT PRIOR TO COMMENCEMENT OF CONSTRUCTION.
- ALL DIMENSIONS ARE TO FACE UNLESS OTHERWISE NOTED.
- CONTRACTOR TO COMPLETE LAYOUT TO APPROVAL OF LANDSCAPE ARCHITECT PRIOR TO ANY CONSTRUCTION.
- ALL DIMENSIONS ARE TO BE MEASURED TO ORIGINAL LOCATION OF LOT CORNERS UNLESS OTHERWISE NOTED.
- ALL WORK SHALL BE IN ACCORDANCE WITH THE CANADIAN BUILDING CODE AND ALL SUPPLEMENTARY REGULATIONS, ORDINANCES, AND BY-LAWS.
- THE DRAWING IS TO BE READ IN CONJUNCTION WITH ALL OTHER PROJECT DRAWINGS AND SPECIFICATIONS.
- ALL DIMENSIONS, DIMENSIONS AND COORDINATES ARE TO BE MEASURED FROM THE INTERSECTION OF THE LOT LINES AND THE ADJACENT LOT LINES.
- THE DRAWING IS AN INSTRUMENT OF SERVICE AND NOT A CONTRACT. THE CONTRACT IS THE AGREEMENT BETWEEN THE CLIENT AND THE ARCHITECT.
- CONTRACTOR SHALL BE RESPONSIBLE FOR OBTAINING ALL NECESSARY PERMITS AND APPROVALS FOR CONSTRUCTION.
- THESE SHALL BE PLANNED IN A MINIMUM DISTANCE OF 0.3M FROM EXISTING PROPOSED UTILITY LINES.
- ALL DIMENSIONS IN MILLIMETRES UNLESS OTHERWISE NOTED.
- DO NOT SCALE DRAWING.
