## **Executive Summary**

EXP Services Inc. (EXP) was retained by Bryton Capital Corporation to complete a Phase I Environmental Site Assessment (ESA) of the vacant lot located at 16 and 20 Cedarow Court in Ottawa, Ontario, hereinafter referred to as the 'site'. This Phase I ESA serves an update to the Phase I ESAs completed by EXP (formerly Trow Associates Inc.) in 2003 and 2009, and 2014.

The purpose of this Phase I ESA was to determine if past or present site activities have resulted in actual or potential contamination at the site. This Phase I ESA will be used for due diligence. EXP understands this report will not be used to support a City of Ottawa permit application or to submit a Record of Site Condition due to a change in land use.

The work was completed in accordance with the general requirements of CSA Standard Z768-01, November 2001 (as amended), which outlines the protocol for Phase I Environmental Site Assessments. As per Z768-01, the scope of work included a review of historical land use and occupancy records, a visual reconnaissance of the subject site and surrounding properties; and interviews with person(s) having knowledge of past and present site activities.

Please note that general environmental management and housekeeping practices were reviewed as part of this assessment insofar as they could impact the environmental condition of the property, however, a detailed review of regulatory compliance issues was beyond the scope of our investigation. This Phase I ESA does not constitute an audit of environmental management practices, indicate geotechnical conditions or identify geologic hazards.

A written response from some of the regulatory agencies typically requires several months to receive. If upon receipt of the response from the regulatory agencies, significant environmental issues are identified, EXP will forward their response to the client as an addendum to this report.

The site is located on the north side of Hazeldean Road and east of Cedarow Court at 16 and 20 Cedarow Court in Ottawa. The PINs for the 2 parcels are 044660067 and 044661799. The site has an area of 3.04 hectares, is currently vacant and is covered with low vegetation and some trees to the north. The property has a gentle slope to the northwest towards Poole Creek, a tributary of the Jock River, to the north. However, a steep downward incline is present when nearing Poole Creek. Access to the site is provided by Cedarow Court, which extends into the property at the western property limits. The site does not have any services such as municipal water and wastewater services. Electricity, cable, and natural gas are also not provided to the site. There are no buildings on the site.



The subject property is located within a mixed agricultural, residential and commercial part of the Stittsville area of Ottawa. The property is bounded: by Poole Creek to the northwest; vacant undeveloped lands to the east; Hazeldean Road followed by sparse residential lands to the south, and service commercial properties to the west. The local groundwater flow direction is anticipated to be northwest towards Poole Creek, 10 to 20 m north of the site.

Based on the results of the Phase I ESA completed at 16 and 20 Cedarow Court in Ottawa, EXP has not identified any areas of potential environmental concern. No additional work in the form of a Phase II ESA is recommended at this time.

This executive summary is a brief synopsis of the report and should not be read in lieu of reading the report in its entirety.

#### 1. Introduction

EXP Services Inc. (EXP) was retained by Bryton Capital Corporation to complete a Phase I Environmental Site Assessment (ESA) of the vacant lot located at 16 and 20 Cedarow Court in Ottawa, Ontario, hereinafter referred to as the 'site'. This Phase I ESA serves an update to the Phase I ESA completed by EXP (formerly Trow Associates Inc.) in 2003, 2009, and 2014.

At the time of the investigation, the site was owned by the Canadian Mortgage and Housing Corporation and is managed by Bryton Capital Corporation. The owner contact information is provided below:

#### 1.1 Objective

This Phase I ESA will be used for due diligence purposes. EXP understands this report will not be used to support a City of Ottawa permit application or to submit a Record of Site Condition (RSC) due to a change in land use.

A Phase I ESA is a systematic qualitative process to assess the environmental condition of a site based on its historical and current uses. The Phase I ESA was completed in general accordance to CSA Standard Z768-01, November 2001 (as amended). Subject to this standard of care, EXP makes no express or implied warranties regarding its services and no third-party beneficiaries are intended. Limitation of liability, scope of report and third-party reliance are outlined in Section 8 of this report.

#### 1.2 Site Description

The site is located on the north side of Hazeldean Road, and east of Cedarow Court at 16 and 20 Cedarow Court in the Stittsville area of Ottawa, as shown on Figure 1 in Appendix B. ## 2. Scope of Investigation

The scope of work the Phase I ESA consisted of the following activities:

- Reviewing the historical occupancy of the subject site through the use of available archived and relevant municipal and business directories, fire insurance plans (FIPs), topographical maps, and aerial photographs;
- Contacting municipal and provincial agencies to determine the existence of records of environmental regulatory non-compliance, if any, and reviewing such records where available;
- Obtaining an EcoLog Environmental Risk Information Services Ltd. (ERIS) report for the subject site and surrounding properties within a 250 metre radius of the site:
- Reviewing available geological maps, well records and utility maps for the vicinity of the subject site;
- Conducting a site reconnaissance of the subject site and building facilities in order to identify the presence of actual and/or potential environmental contaminants or concerns of significance;
- Conducting interviews with designated site representative(s) as a resource for current and historical site information, as well as to provide EXP staff with unrestricted access to all areas of the subject site and site buildings;
- Reviewing the current use of the subject site and any land use practices that may have impacted its environmental condition;
- Reviewing the current use of the surrounding properties and any land use practices that may have impacted the environmental condition of the subject site; and.
- Preparing a report to document the findings.

In completing the scope of work, EXP did not conduct any intrusive investigations, including sampling, analyses or monitoring of materials. In addition, general environmental management and housekeeping practices were reviewed as part of this assessment insofar as they could impact the environmental condition of the property; however, a detailed review of regulatory compliance issues was beyond the scope of our investigation.

EXP personnel who conducted assessment work for this project included Mark McCalla, P.Geo. and Robert Renaud, M.Sc., P. Geo. An outline of their qualifications is provided in Appendix A.



#### 3. Records Review

#### 3.1 Phase I ESA Study Area Determination

EXP conducted a records review of available information in accordance with CSA Standard Z768-01 to establish the land use history of the subject site and the adjacent properties.

The Phase I ESA study area consisted of the neighbourhood extending a distance of 250 metres from the subject site. At the time of the site reconnaissance, land usage within 250 metres of the subject site was mixed agricultural, residential and commercial. Figure 2 in Appendix B highlights near-by properties within the study area.

#### 3.2 First Developed Use Determination

Based on a review of historical aerial photographs, historical maps, and other records review, it appears the subject site has always been vacant.

#### 3.3 Title Search

A title search was not conducted as part of this assessment.

#### 3.4 Fire Insurance Plans

The Catalogue of Canadian Fire Insurance Plans 1875 – 1975 (Catalogue) was used to determine if fire insurance plans (FIPs) for the subject site exist. No FIP were historically produced for the immediate area.

#### 3.5 Site Operating Records

No site operating records were provided to EXP for review.

#### 3.6 Environmental Reports

The following environmental reports were reviewed:

- Phase I Environmental Site Assessment, Hazeldean Land, Goulbourn Township, Ottawa, Ontario; Trow Associates Incorporated, August 2003;
- Phase I Environmental Site Assessment Hazeledean Lands, Ottawa, Ontario. Trow Associates Incorporated, April 2009; and.
- Phase I Environmental Site Assessment, 16 and 20 Cedarow Court, Ottawa, Ontario; EXP Services Inc., January 12, 2014.

At the time of these investigations the site was vacant and undeveloped. An automotive garage was observed on the neighbouring site to the west and an automotive sales business was observed 50 m to the southwest. Due to the inferred northwesterly groundwater flow direction and the fact that there were no below ground structures such as underground storage tanks or in-ground hydraulic hoists observed at the automotive garage, no areas of potential environmental concern (APECs) were identified.

In 2015, EXP completed a Phase One and Two ESA for a former service garage and gasoline station located at 5835 Hazeldean Road, approximately 170 m west of the subject site. No soil or groundwater impacts were identified during the assessment.



#### 3.7 Regulatory Information Environmental Source Information

The appropriate regulatory agencies at the provincial and municipal levels were contacted to obtain information regarding environmental permits, past or pending environmental control orders or complaints, outstanding environmental regulatory non-compliance issues and Sewer Use By-Law infractions. EXP did not identify the need to contact any federal agencies.

The following agencies were contacted:

- The Ontario Ministry of the Environment and Climate Change (MOECC) Freedom of Information, Protection of Privacy Office;
- The Technical Standards and Safety Authority (TSSA), Fuel Safety Branch, and;
- The City of Ottawa.

A written response from some of the regulatory agencies typically requires several weeks to months. Copies of the requests are included in Appendix D. If upon receipt of the response from these regulatory agencies, significant environmental issues are identified, EXP will forward their response to the client as an addendum to this report.

#### 3.7.1 Ontario Ministry of the Environment and Climate Change Records

Records pertaining to the site were requested from the MOECC through the *Freedom of Information and Protection of Privacy Act* (FOI). A response dated December 29, 2014 indicates that no records were located for this property. A copy of the response is included in Appendix D of this report.

On May 10, 2018, the MOECC Environmental Bill of Rights (EBR) registry website was searched by EXP for postings in the vicinity of the subject site using a 250 m radius. Only one listing was found. Bryton Capital Corporation withdrew their application for a permit to transplant eight Butternut trees (Juglans cinerea) for the purpose of constructing a commercial development at the site. The regulation requires the proponent to submit a Butternut health assessor's report and a planting plan which requires between two and 20 seedlings to be planted for every tree removed or harmed (based on the size of tree). Additionally, it requires monitoring, tending and reporting to MNR on the growing progress of the newly planted Butternut. No APECs were identified.

On May 11, 2018, the MOECC Brownfields Registry website was searched by EXP for postings of Records of Site Condition. No postings were listed for the subject site. A RSC was posted for the property on the north side of Poole Creek.

The following on-line sources of information were reviewed searched by Environmental Risk Information Service Limited (ERIS):

 On May 23, 2018, the MOECC Hazardous Waste Information Network (HWIN) database was searched by ERIS for registered waste generators in the vicinity of the subject site. These results are presented in the EcoLog Report and further discussed in Section 3.9.

#### 3.7.2 Municipal Records

#### 3.7.3.1 City Hall Records

A request was made to the City of Ottawa for the Hazardous Land Use Inventory (HLUI). The following entries were identified:

• Carruthers Garage, 5 Cedarow Court (adjacent to southwest) - an automotive service garage listed as in operation in 2005.



- Renwick Auto Sales, 3 Cedarow Court (adjacent to west) an automotive service garage listed as in operation from 1997 to 2005. Was also listed as Krown Rust Proofing (2001 and 205) and Auto Searchers Ltd.
- Infineon Technologies, 10 Cedarow Court (70 m to west) electrical and electronic machinery in operation 2001.

Due to the inferred northwesterly groundwater flow direction and the fact that there were no below ground structures such as underground storage tanks or in-ground hydraulic hoists observed at the automotive garages, no APECs were identified. A copy of the response is provided in Appendix D.

#### 3.7.3.2 City Directory Search

EXP reviewed city directories at the national archives library in order to identify the occupancy history of the subject site and neighbouring properties for potential environmental concerns. No listings were available for the site because it is a vacant lot.

The adjacent properties are considered cross-gradient to the site in terms of groundwater flow and therefore do not represent an APEC to the subject site.

#### 3.8 Land Use Documents

A review of the following publications was carried out as part of this Phase I ESA:

- 1. Waste Disposal Site Inventory (MOE, June 1991);
- 2. Old Landfill Management Strategy Phase 1 Identification of Sites, City of Ottawa, Ontario (Golder Associates, October 2004);
- 3. Inventory of Coal Gasification Plant Waste Sites in Ontario (Intera, April 1987);
- 4. Mapping and Assessment of Former Industrial Sites City of Ottawa (Intera, July 1988); and,
- 5. Ontario Ministry of the Environment; 1993; Ontario Inventory of PCB Storage Sites.

Waste Disposal Site Inventory - Ontario MOE (1991) - Active and Closed Landfills

There were no waste disposal sites identified in this document within 250 m of the subject site.



Old Landfill Management Strategy Phase 1 – Identification of Sites - Golder (2004)

There were no landfills identified in this document within 250 m of the subject site.

Inventory of Coal Gasification Plant Waste Sites in Ontario - Ontario MOE (1987)

There were no coal gasification plants identified in this document within 250 m of the subject site.

Mapping and Assess Former Industrial Sites – Intera (1988)

No former industrial sites were identified within 250 m of the subject site.

Ontario Inventory of PCB Storage Sites - Ontario MOE (1993

No records pertaining to PCB storage sites were identified within 250 m of the subject site in this document.

#### 3.9 EcoLog ERIS Database Search

A search of provincial and federal databases for records pertaining to the subject site and properties within 250 metres of the subject site was conducted by EcoLog Environmental Risk Information Services (or EcoLog ERIS). EcoLog ERIS is an environmental database and information service provider. EXP has confirmed neither the completeness nor the accuracy of the records that were provided. A summary of the more significant findings is provided below. A copy of the EcoLog ERIS report is provided in Appendix C.

All of the above noted entries are considered cross gradient and/or at large intervening distances from the site. Based on the information reviewed, no APECs were identified.



#### 3.10 Physical Setting Review

#### 3.10.1 Aerial Photographs

Aerial photographs from 1968, 1976, 1984, 1992, 1999, 2007 and 2014 were examined in an effort to review the historical land use at the site and adjacent properties.

- In the 1964 and 1976 aerial photographs, the subject property appears to be of an agricultural nature along with other properties in the area. No buildings were observed on the subject site.
- In the 1984 aerial photograph, the parking area for a number of off-site buildings extended into the
  northwestern portion of the subject property. At the time, the subject property appears to have been
  of an agricultural nature and it is suspected that the above-noted buildings were for agricultural
  purposes. The former off-site buildings were not identified in the 1984 aerial photograph.
- Based on 1992 and 1999 aerial photographs, the neighbouring garage and car wash facilities to the west of the property (on Cedarow Court) are present.
- Based on the 2007 to 2014 aerial photographs, several properties occupy Cedarow Court and appear to be small commercial buildings. No evidence of industrial facilities and/or retail fuel outlets were identified.
- In the 2017 aerial photograph, there is a large vehicle parking area located just west of Poole Creek. No other changes are noted for the site or surrounding area.t

Based on the review of the aerial photographs, no APECs were noted.

#### 3.10.2 Geology, Hydrogeology and Topography

The following information sources were reviewed to determine the nature of the subsurface materials at the site:

- 1. Bedrock Geology of Southern Ontario Ontario Geological Survey. Scale 1:50,000. Electronic resource Issued 2003.
- 2. Surficial Geology of Southern Ontario Ontario Geological Survey. Scale 1:50,000. Electronic resource Issued 2003.
- Ontario Geotechnical Boreholes Electronic Resource.
- 4. MOECC Water Well Records Electronic Resource.
- 5. Department of Natural Resources, Topographic Mapping. Electronic Resource.

Based on local mapping, beneath any fill, the surficial geology of the site is characterised by clay and silt. The bedrock geology underlying the subject site consists of limestone of the Bobcaygeon Formation. Local MOECC well records and geotechnical boreholes indicate local geology is sand and silt over limestone bedrock. The depth to bedrock is approximately 2 m below grade.

The site topography has a gentle slope downwards towards Poole Creek. The local groundwater flow direction is anticipated to be north towards Poole Creek, 10-20 m north of the site.

#### 3.10.3 Water Bodies and Areas of Natural Scientific Importance

There are no water bodies on the subject site. The closest body of water is Poole Creek located 10-20 m north of the site. The site is not located near an ANSI.



### 3.11 Summary of Records Review

Based on a review of the available records, no APECs have been identified.



#### 4. Interviews

Interviews were conducted by EXP with the individuals identified to be the most knowledgeable about both the current and historical site uses. The interviews were conducted in order to obtain information to assist in identifying areas of potential environmental concern and identify details of potentially contaminating activities or potential contaminant pathways, in, on or below the subject site.

During the completion of this Phase I ESA, Ms. Lorna Pineda of Bryton Capital Corporation was interviewed via email. She indicated that:

- The site has always been vacant and undeveloped.
- There are and never have been any tanks or chemical storage at the site.
- There are no known environmental issues with the site.



#### 5. Site Reconnaissance

#### 5.1 General Requirements

On May 10, 2018, Mark McCalla. P.Geo., of EXP conducted the site visit in accordance with EXP's internal health and safety protocols and with the Ministry of Labour health and safety regulations. The purpose of the site visit was to assess the current conditions of the subject site.

The general environmental management and housekeeping practices at the subject site were reviewed as part of this assessment insofar as they could impact the environmental condition of the property; however, a detailed review of regulatory compliance issues was beyond the scope of EXP's investigation.

Exterior observations of the subject property and surrounding properties were conducted. The exterior observations were recorded by walking over the grounds of the subject site. Adjoining properties were observed from within the grounds of the subject site.

Photographs were taken from the exterior and interior of the building. Photographs are included in Appendix E. Mr. McCalla was unaccompanied during the site visit.

#### 5.2 Visual Site Assessment

#### 5.2.1 Site Description and Buildings

The site has an area of 3.04 hectares, is currently vacant, and is covered with low vegetation and some trees to the north. The property displays a gentle slope towards Poole Creek, to the northwest. However, a steep downward incline is present when nearing Poole Creek. Access to the site is provided by Cedarow Court, which extends into the property at the western property limits of the site. There are no buildings on the site.

#### 5.2.2 Site Use

The site was vacant and undeveloped during the site visit.

#### 5.2.3 Heating and Cooling Systems

The site was not serviced with heating or cooling services.

#### 5.2.4 Site Utilities and Services

The site was not serviced with any utilities.

#### 5.2.5 Storage Tanks

#### 5.2.5.1 Underground Storage Tanks

The site representative indicated they had no knowledge of underground storage tanks (USTs) at the site. EXP did not observe any evidence of USTs during the site reconnaissance. Furthermore, the historical review did not identify any former USTs at the site.



#### 5.2.5.2 Aboveground Storage Tanks

The site representative indicated they had no knowledge of above ground storage tanks (ASTs) at the site. EXP did not observe any evidence of ASTs during the site reconnaissance. Furthermore, the historical review did not identify any former ASTs at the site.

#### 5.2.6 Drains, Pits and Sumps

No drains, sumps, or pits were observed at the site during the site inspection.

#### 5.2.7 Chemical Storage and Handling and Floor Condition

No chemical storage was observed at the site.

#### 5.2.8 Areas of Stained Soil, Pavement or Stressed Vegetation

No areas of stained soil were present during the site inspection.

#### 5.2.9 Fill, Debris and Methane

The subject site is at approximately the same elevation as the surrounding properties and as such substantial quantities of fill are not anticipated to be present at the subject site. Methane or radon gas-producing materials were not observed on the subject site.

#### 5.2.10 Air Emissions

Regulatory control of air emissions in Ontario is the responsibility of the MOE. According to the Environmental Protection Act (EPA), an Environmental Compliance Approval (ECA) (Air) is required for the ongoing operation of any equipment that may discharge a contaminant into the natural environment if the equipment was installed, modified or altered after June 29th, 1988. Retroactive approval should be sought for equipment installed and unchanged between 1972 and June 29th, 1988 when the requirement for a ECA was added to the EPA. Unless explicitly exempted, most industrial processes or modifications to industrial processes and equipment require a ECA. The EPA provides a list of specific equipment and conditions, which are exempt from ECA (Air) requirements (i.e. fuel burning equipment for comfort heating in a building using natural gas or number 2 fuel oil at a rate of less than 1.5 million British Thermal Units per hour [BTU/hour]).

No air emissions concerns were identified at the time of the site visit.

#### 5.2.11 Odours

No strong odours were detected during the site visit.

#### 5.2.12 Noise

No excessive noise was detected at the subject site during the site visit.

#### 5.2.13 Special Attention Items, Hazardous Building Materials and Designated Substances

Special attention substances such as asbestos, PCBs, lead paint, and urea formaldehyde foam insulation were commonly used in older buildings. Given that the site is vacant (i.e. there are no buildings on the subject property), special attention substances are not present on the site.



#### 5.2.13.6 Radon

Radon is a colourless, odourless, radioactive gas that occurs naturally in the environment. It comes from the natural breakdown of uranium in soils and rocks. Exposure to high levels of radon increases the risk of developing lung cancer. This relationship has prompted concern that radon levels in some Canadian buildings may pose a health risk. Radon gas can move through small spaces in the soil and rock and seep into a building through cracks in concrete, sumps, joints and basement drains. Concrete-block walls are particularly porous to radon and radon trapped in water from wells can be released into the air when the water is used.

Due to the potential health concerns associated with radon, Health Canada released a guideline in June 2007 for a maximum acceptable level of radon gas of 200 Becquerels per cubic metre (Bq/m³). Where radon gas is present and the annual radon concentration exceeds 200 Bq/m³ in the normal occupancy area, Health Canada recommends taking the necessary actions to reduce radon levels.

Given the absence of any structure on the site and the geological formation underlying the site, EXP concludes that radon is highly unlikely to pose a direct health concern.

#### 5.2.13.7 Mould

Mould is found in the natural environment and is required for the breakdown of plant debris such as leaves and wood. Mould spores are found in the air in both the indoor and outdoor environments. In order for mould to grow it requires a food source (i.e. gypsum wallboard, carpets, wallpaper, wood, etc.) and moist conditions. Mould can have an impact on human health depending on the species and concentration of the mould. Health effects can include allergies and mucous membrane irritation.

Currently there are no regulations governing mould; however, there are several guidelines addressing mould assessments and abatement. At the moment the industry standards include the Canadian Construction Association (CCA) document 82-2004 titled "mould guidelines for the Canadian construction industry" and the Environmental Abatement Council of Ontario (EACO) guidelines titled "EACO Mould Abatement Guidelines, Edition 2 (2010)".

It is important to note that the Ministry of Labour (MOL) has governed protecting workers under the Occupational Health and Safety Act, which states that employers are required to take every precaution reasonable to protect their workers. This includes protecting workers from mould within workplace buildings.

No visible mould was observed by EXP in the site building during the site visit.

#### **5.2.14 Processing and Manufacturing Operations**

No processing or manufacturing operations take place at the subject site.

#### 5.2.15 Hazardous Materials Use and Storage

No hazardous materials were observed at the site.

#### 5.2.16 Vehicle and Equipment Maintenance Areas

No vehicle and equipment maintenance areas were observed at the site.

#### 5.2.17 Oil/Water Separators

No oil/water separators were observed on the site.



#### 5.2.18 Sewage and Wastewater Disposal

The subject site was not serviced with sanitary services.

#### 5.2.19 Solid Waste Generation, Storage & Disposal

Solid waste is not generated on the site. Some minor litter was observed across the site during previous assessments however this does not represent an APEC.

#### 5.2.20 Liquid Waste Generation, Storage & Disposal

No significant liquid wastes are generated at the site.

#### 5.2.21 Hydraulic Lift Equipment

Mechanical equipment such as piston type elevators, vehicle in-ground hoists, loading docks and compactors are typically hydraulically operated. As such, these types of equipment contain hydraulic oils which are operated under high pressures and can be released into the environment from leaks or equipment failures.

No stationary hydraulic lift equipment was observed at the subject site.

#### 5.2.22 Mechanical Equipment

No mechanical equipment was observed at the site.

#### 5.2.23 Abandoned and Existing Wells

No wells were observed at the site.

#### 5.2.24 Roads, Parking Facilities and Right of Ways

The subject site has road access from Cedarow Court to the west. No rights-of-way have been registered on the property.

#### 5.3 Adjacent and Surrounding Properties

A visual inspection of the adjacent properties and properties within 250 m of the subject site was conducted from publicly accessible areas to identify the occupants and document the uses and sources of potential environmental concerns that may impact the subject site. The results of the visual inspection are documented in Figure 2 Appendix B.

North: Vacant followed by residential

South: across Hazeldean Road, parkland followed by residential

East: Seniors residence under construction

West: Commercial (Self Serve Car Wash, Krown Rust Proofing, Automotive Garage (Auto Searchers Ltd.), Fitness Centre, Automotive Sales, Winds of Change Spa)

#### 5.4 Summary of Site Reconnaissance

Based on the site reconnaissance, no APECs have been identified for the site.



# 6. Findings and Recommendations

Based on the results of the Phase I ESA updated conducted at 16 and 20 Cedarow Court, EXP did not identify any APECs. No further work in the form of a Phase II ESA is recommended at this time.


