KEY PLAN



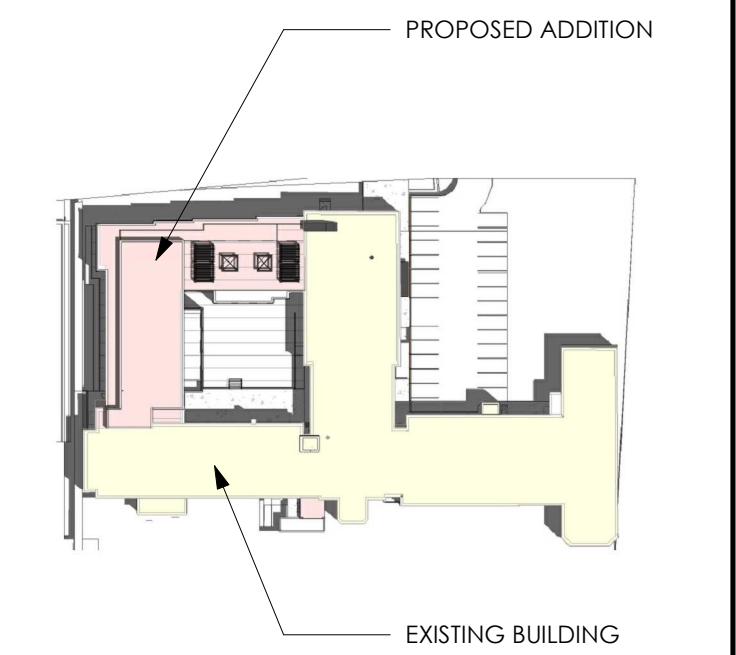
