Further to your request, Paterson Group (Paterson) conducted a Phase I - Environmental Site Assessment (Phase I ESA) Update for the aforementioned property. This report updates a previous Phase I ESA report completed by Paterson, dated March 15, 2018, and is intended to meet the requirements of a Phase I ESA, as per the MECP Standard O.Reg. 153/04, as amended, under the Environmental Protection Act. This report is to be read in conjunction with the previous report.

Site Information

The Phase I Property is located on the north side of Navan Road, approximately 35 m south of Birkhill Place, in the City of Ottawa, Ontario. The Phase I Property is currently vacant and forested land.

Site drainage occurs primarily through infiltration or runoff to the ditch located on the site. The Phase I Property is generally flat and at the grade of Navan Road.


The Phase I Property is shown on Drawing PE4245-1R – Site Plan.

Records Review

Phase I ESA Study Area Determination

A radius of approximately 250 m was determined to be appropriate as a Phase I Study Area for this assessment. Properties outside the 250 m radius are not considered to have the potential to impact the Phase I Property, based on their separation distance.





First Developed Use Determination

For the purposes of this report, and based on aerial photographs and the documentation reviewed, the Phase I Property is considered to have been first developed as early as 1945 for residential purposes.

Plan of Survey

A survey plan for the Phase I Property has been prepared by Annis, O'Sullivan, Vollebekk Ltd., dated 2018, and was reviewed as part of this assessment. The plan depicts the Phase I Property in its current configuration.

Previous Engineering Reports


The following report was reviewed prior to conducting this assessment:

'Phase I Environmental Site Assessment, Vacant Land, 3317 Navan Road, Ottawa, Ontario', prepared by Paterson Group, dated March 15, 2018.

According to historical research conducted as part of the 2018 Phase I ESA, the Phase I Property was developed for residential purposes as early as 1945. The residential dwelling on the Phase I Property was demolished sometime between 1965 and 1976 and the Phase I Property has remained vacant since that time. The usage of the Phase I Property prior to the construction of the residential building was inferred to consist of vacant/agricultural lands. No environmental concerns were identified with respect to the historical use of the Phase I Property.

One historical PCA was identified within the Phase I Study Area. The property addressed 3354 Navan Road, approximately 30 m south of the Phase I Property (at its nearest point), was identified as the Navan Landfill, however the activities of concern on the 3354 Navan Road property are considered to have occurred a minimum of 320 m southeast of the Phase I Property. Due to the separation distance of the activities of concern and the downgradient orientation with respect to the Phase I Property, the 3354 Navan Road property is not considered to represent an environmental concern on the Phase I Property.

Following the historical research, an inspection of the Phase I Property and surrounding lands was conducted. No environmental concerns were identified on the Phase I Property at the time of the site visit.



The property addressed 3252 Navan Road, approximately 25 m southwest of the Phase I Property, was identified as André Taillefer Ltd., an excavation contractor facility. Two aboveground storage tanks (ASTs) were identified approximately 75 m southwest of the Phase I Property on the 3252 Navan Road property. Based on the separation distance of the storage tanks and the down-gradient orientation with respect to the Phase I Property, the 3252 Navan Road property was not considered to represent an environmental concern on the Phase I Property.

Environment Canada

A search of the National Pollutant Release Inventory (NPRI) was conducted electronically on January 5, 2023. The Phase I Property was not listed in the NPRI database. No new records of pollutant release were listed in the database for properties located within the Phase I Study Area.

Areas of Natural Significance

A search of natural significance and features within the Phase I Study Area was conducted on the website of the Ontario Ministry of Natural Resources (MNR) on January 5, 2023. The search did not reveal any areas of natural significance within the Phase I Study Area.


Ministry of the Environment, Conservation and Parks (MECP) Instruments

A request was submitted to the MECP Freedom of Information (FOI) office for information with respect to certificates of approval, permits to take water, certificates of property use or any other similar MECP issued instruments for the Phase I Property. At the time of issuance of this report, a response from the MECP had not been received. A copy of the response will be forwarded to the client, should it contain any pertinent information.

As part of the initial Phase I ESA conducted for the Phase I Property, an MECP FOI search was conducted. The response from the MECP for the initial FOI search contained one certificate of approval record dated June of 2010, pertaining to municipal and private sewage works to be constructed on Glenlivet avenue, Birkhill Place and Renaud Road. This certificate of approval is not considered to represent an environmental concern to the Phase I Property.

MECP Submissions

A request was submitted to the MECP FOI office for information with respect to reports related to environmental conditions for the Phase I Property. At the time of issuance of this report, a response from the MECP had not been received. A copy of the response will be forwarded to the client, should it contain any pertinent information.



As part of the initial Phase I ESA conducted for the Phase I Property, an MECP FOI search was conducted. The response from the MECP for the initial FOI search contained no MECP Submissions records.

MECP Incident Reports

A request was submitted to the MECP FOI office for information with respect to records concerning environmental incidents, orders, offences, spills, discharges of contaminants or inspections maintained by the MECP for the site or adjacent properties. At the time of issuance of this report, a response from the MECP had not been received. A copy of the response will be forwarded to the client, should it contain any pertinent information.

As part of the initial Phase I ESA conducted for the Phase I Property, an MECP FOI search was conducted. The response from the MECP for the initial FOI search contained no MECP Incident Report records.

MECP Waste Management Records

A request was submitted to the MECP FOI office for information with respect to waste management records. At the time of issuance of this report, a response from the MECP had not been received. A copy of the response will be forwarded to the client, should it contain any pertinent information.

As part of the initial Phase I ESA conducted for the Phase I Property, an MECP FOI search was conducted. The response from the MECP for the initial FOI search contained no MECP Waste Management records.


MECP Coal Gasification Plant Inventory

The Ontario Ministry of Environment document titled "Municipal Coal Gasification Plant Site Inventory, 1991" was reviewed to reference the locations of former plants with respect to the site. No Municipal Coal Gasification Plant Sites are located within the Phase I Study Area.

MECP Brownfields Environmental Site Registry

A search of the MECP Brownfields Environmental Site Registry was conducted as part of this assessment for the site, neighbouring properties and the general area of the site. One Record of Site Condition (RSC) was found for the Phase I Property, dated May 7, 2009. A review of the RSC filing did not identify any concerns on the Phase I Property.

A second RSC was identified for a property approximately 100m southwest of the Phase I Property (with no municipal address), dated March 24, 2017. Based on information provided in the RSC report, soil and groundwater met the applicable MECP standards. The second RSC property is not considered to pose a concern to the Phase I Property.



MECP Waste Disposal Site Inventory

The Ontario Ministry of Environment document titled "Waste Disposal Site Inventory in Ontario, 1991" was reviewed as part of the historical research. This document includes all recorded active and closed waste disposal sites, industrial manufactured gas plants and coal tar distillation plants in the Province of Ontario. There are no former waste disposal sites located within 250 m of the Phase I Study Area.

As previously mentioned, the Navan Landfill is located south of the Phase I Property. Based on the separation distance and down-gradient orientation with respect to the Phase I Property, the landfill is not considered to represent an environmental concern to the Phase I Property.

Technical Standards and Safety Authority (TSSA)

The TSSA, Fuels Safety Branch in Toronto, was contacted electronically on January 5, 2023, to inquire about current and former underground storage tanks, spills and incidents for the site and neighbouring properties. A response from the TSSA indicated that no records were listed in the TSSA registry for the Phase I Property or neighbouring properties. A copy of the TSSA response has been appended to this report.

City of Ottawa Landfill Document


The document entitled "Old Landfill Management Strategy, Phase I – Identification of Sites, City of Ottawa", was reviewed. No former waste disposal sites were identified in this document within the Phase I study area.

As previously mentioned, the Navan Landfill is located south of the Phase I Property. Based on the separation distance and down-gradient orientation with respect to the Phase I Property, the landfill is not considered to represent an environmental concern to the Phase I Property.

City of Ottawa Historical Land Use Inventory (HLUI)

As part of this assessment, a requisition form was submitted to the City of Ottawa to request information from the City's Historical Land Use Inventory (HLUI 2005) database for any environmental records pertaining to the Phase I Property as well as any properties situated within the Phase I study area.

A response from the City had not been received prior to the issuance of this report. A copy of the response will be forwarded to the client should it contain any pertinent information. A copy of the submission request has been appended to this report.



As part of the initial Phase I ESA for the subject property, a requisition form was sent to the City of Ottawa to request information from the City's Historical Land Use Inventory (HLUI) database for the Phase I Property. The response from the City of Ottawa identified two records for properties within the Phase I Study Area. The 3252 Navan Road property, approximately 25 m southwest of the Phase I Property, was identified as André Taillefer Ltd., a construction contractor facility. The property addressed 3354 Navan Road, approximately 30 m south of the Phase I Property (at its nearest point), was identified as Waste Service (CA) Inc. (the Navan Landfill), however the activities of concern on the 3354 Navan Road property are considered to have occurred a minimum of 320 m southeast of the Phase I Property. Due to the separation distance of the activities of concern and the down-gradient orientation with respect to the Phase I Property, the records identified in the City of Ottawa HLUI response are not considered to represent an environmental concern on the Phase I Property.

Environmental Risk Information Service (ERIS) Report

An ERIS (Environmental Risk Information Service) Report was obtained for the Phase I Property and surrounding lands. It should be noted that the ERIS report includes information that can normally be obtained through the MECP FOI, MECP well records search as well as several other records (i.e., incident reports, waste generators, etc.). The complete ERIS report has been included in Appendix 1.


The ERIS report identified two records for the Phase I Property. The two records identified for the Phase I Property include a historical ERIS search and the RSC filing previously discussed in the MECP Brownfields Environmental Site Registry section of this report.

A total of eight records (4 of which are historical ERIS searches) from various databases were identified for properties within the 250m radius of the Phase I Property.

The ERIS report identified one Environmental Registry record for the property addressed 3323 Navan Road, adjacent to the east of the Phase I Property. The record is dated September of 2017 and lists no pertinent information. This record is not considered to represent an environmental concern to the Phase I Property.

The ERIS report identified two Water Well Information System records. One record was a well abandonment record dated December of 2015 and one record, dated May of 2021, had no pertinent information listed. These records are not considered to be representative of a potential environmental concern to the Phase I Property.

The ERIS report identified one Environmental Compliance Approval record for the property addressed 3253 Navan Road, adjacent to the west of the Phase I Property. The record is dated June of 2010, pertaining to sewer works and is not considered to pose an environmental risk to the Phase I Property.



Aerial Photographs

The latest aerial photograph reviewed for the 2018 Phase I ESA was from 2017. A review of the 2021 aerial photograph shows no significant changes to the Phase I Property or the surrounding lands. A copy of the 2021 aerial photograph has been appended to this report.

Topographic Maps

Topographic maps were obtained from Natural Resources Canada – The Atlas of Canada website and from the City of Ottawa website. Regionally, the topographic maps indicate the Phase I Property is approximately 80 m above sea level and regional topography in the general area of the Phase I Property slopes gently downward to the southwest. An illustration of the referenced topographic map is presented on Figure 2 – Topographic Map, appended to this report.

Physiographic Maps


A Physiographic Map was reviewed from the Natural Resources Canada – The Atlas of Canada website. According to this physiographic map, the site is located in the St. Lawrence Lowlands. According to the mapping description provided: "The lowlands are plain-like areas that were all affected by the Pleistocene glaciations and are therefore covered by surficial deposits and other features associated with the ice sheets." The Phase I Property is located in the Central St. Lawrence Lowland, which is generally less than 150 m above sea level.

Geological Maps

The Geological Survey of Canada website on the Urban Geology of the National Capital Area was consulted as part of this assessment. Based on this information, bedrock in the area of the site is reported to consist of shale of the Billings Formation. Overburden soils consist of nearshore marine sediments with a drift thickness on the order of 25 to 50 m.

Water Well Records

A search of the MECP 's website for all drilled well records within 250 m of the subject site was conducted on January 5, 2023. No well records were identified for the Phase I Property.



Seven well records were identified for properties within the Phase I Study Area. Five of the records pertain to domestic water supply wells. One record was a well abandonment record dated December of 2015 and one record had no pertinent information listed. The potable wells were drilled to depths ranging from 36 to 45 m below grade and installed within a limestone, shale or slate bedrock layer. The water supply wells were installed from 1962 to 1979 and are not expected to be in current use. Surrounding properties that have been recently developed are currently serviced by the City of Ottawa water system, however, private water wells may still be used by residential dwellings or farmstead located along Navan Road that have not been identified on the MECP website. A copy of the well records has been appended to this report.

Interviews

Mr. Anand Aggarwal, the current property, was interviewed as part of this Phase I ESA Update. Mr. Aggarwal stated that the property was purchased as vacant land by the previous owners in 1987 and has remained as such since that time. Mr. Aggarwal was not aware of any potential environmental concerns regarding the Phase I Property.

Site Reconnaissance

A site reconnaissance visit was conducted on January 5, 2023. Mr. Jeremy Camposarcone from the Environmental Department of Paterson Group conducted the site inspection. In addition to the site, the uses of neighbouring properties within the Phase I Study Area were also assessed at the time of the site visit.

Buildings and Structures


There are no buildings or structures located on the Phase I Property.

Site Features

The Phase I Property was snow covered at the time of the site inspection. The Phase I Property is primarily tree and brush covered and has a relatively flat topography. Site drainage typically occurs through infiltration and runoff to a ditch located through the central portion of the Phase I Property (from east to west).

One pole-mounted transformer was identified adjacent to the south of the Phase I Property, along Navan Road. The transformer was noted to be in good condition with no signs of leaks or staining observed at the time of the site inspection. No concerns were identified with respect to the pole-mounted transformer.

No evidence of ozone-depleting substances (ODSs), underground storage tanks (USTs) or chemical storage was observed on the Phase I Property at the time of the site inspection.



No evidence of recent excavation was observed on the exterior of the Phase I Property. No evidence of current or former railway or spur lines was observed on the subject land at the time of the site visit. There were no unidentified substances observed on the exterior of the Phase I Property.

The above-noted site features are shown on Drawing PE4245-1R - Site Plan.

Neighbouring Properties

An inspection of the neighbouring properties was conducted from publicly accessible roadways at the time of the site inspection. Land use adjacent to the subject site was as follows:

North – Residential dwellings, followed by Birkhill Place and Glenlivet Avenue;
South – Navan Road, followed by a residential dwelling, a residential community under development and an undeveloped parcel of the Navan Landfill;
East – Residential community under development;
West – Residential dwellings.

The Navan Landfill is located approximately 30 m south of the Phase I Property (at its nearest point), however the activities of concern are considered to have occurred a minimum of 320 m southeast of the Phase I Property. As previously mentioned, based on the separation distance and down-gradient orientation with respect to the Phase I Property, the landfill is not considered to represent an environmental concern to the Phase I Property. Aboveground storage tanks previously identified on the property addressed 3252 Navan Road, approximately 25 m southwest of the Phase I Property, were unable to be identified at the time of the site inspection. They were removed as the 3252 Navan Road property is currently under development. Surrounding land use is depicted on Drawing PE4245-2R – Surrounding Land Use Plan, appended to this report.

Assessment of Uncertainty and/or Absence of Information

The information available for review as part of the preparation of this Phase I-ESA Update is considered to be sufficient to conclude that there are no APECs on the Phase I Property. A variety of independent sources were consulted as part of this assessment, and as such, the conclusions of this report are not affected by uncertainty which may be present with respect to the individual sources.

Conclusions

The results of the records review, research, and site inspection indicated that there are no new potential environmental concerns regarding the subject site since the 2018 Phase I ESA. Based on the results of this Phase I ESA Update, in our opinion, a Phase II **Environmental Site Assessment is not required for the property.**

Statement of Limitations

This Phase I - Environmental Site Assessment Update report has been prepared in general accordance with O.Reg. 153/04, as amended. The conclusions presented herein are based on information gathered from a historical review and field inspection program. The findings of the Phase I ESA Update are based on a review of readily available geological, historical and regulatory information and a cursory review made at the time of the field assessment. The historical research relies on information supplied by others, such as local, provincial, and federal agencies and was limited within the scope-of-work, time, and budget of the project herein.

Should any conditions be encountered at the subject site and/or historical information that differ from our findings, we request that we be notified immediately in order to allow for a reassessment.

This report was prepared for the sole use of Manor Park Management. Permission and notification from Manor Park Management and this firm will be required to release this report to any other party.








FIGURE 1 KEY PLAN







FIGURE 2 TOPOGRAPHIC MAP



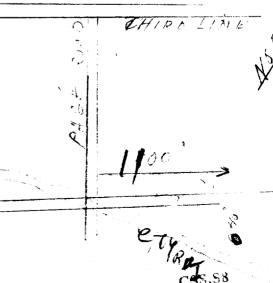

Executive Summary: This portion of the report is divided into 3 sections:

'Report Summary'- Displays a chart indicating how many records fall on the project property and, within the report search radii.

'Site Report Summary'-Project Property'- This section lists all the records which fall on the project property. For more details, see the 'Detail Report' section.

'Site Report Summary-Surrounding Properties'- This section summarizes all records on adjacent properties, listing them in order of proximity from the project property. For more details, see the 'Detail Report' section.

<u>Map Key:</u> The map key number is assigned according to closest proximity from the project property. Map Key numbers always start at #1. The project property will always have a map key of '1' if records are available. If there is a number in brackets beside the main number, this will indicate the number of records on that specific property. If there is no number in brackets, there is only one record for that property.

The symbol and colour used indicates 'elevation': the red inverted triangle will dictate 'ERIS Sites with Lower Elevation', the yellow triangle will dictate 'ERIS Sites with Higher Elevation' and the orange square will dictate 'ERIS Sites with Same Elevation.'

<u>Unplottables:</u> These are records that could not be mapped due to various reasons, including limited geographic information. These records may or may not be in your study area, and are included as reference.
