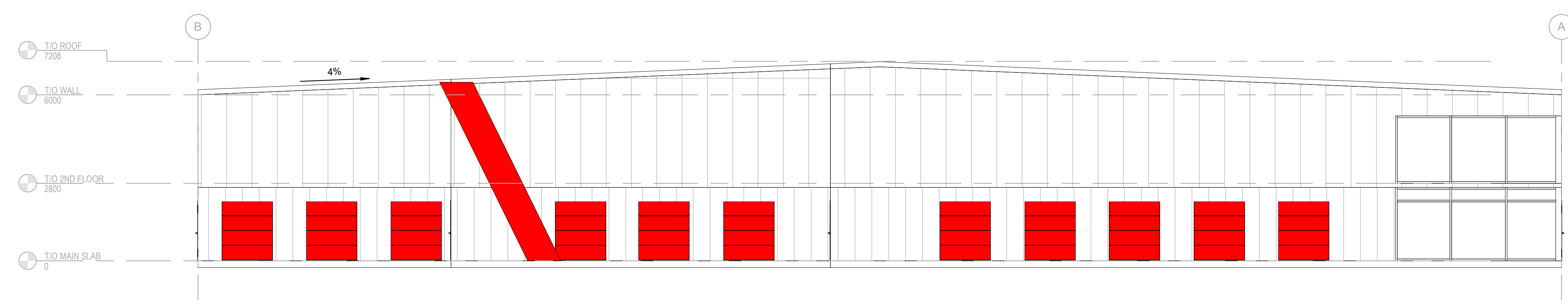

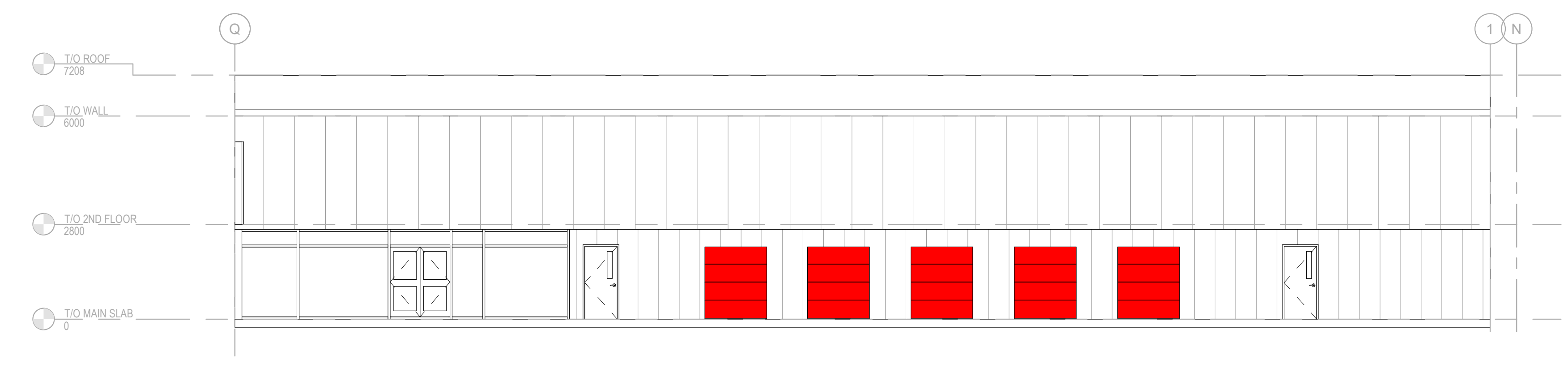

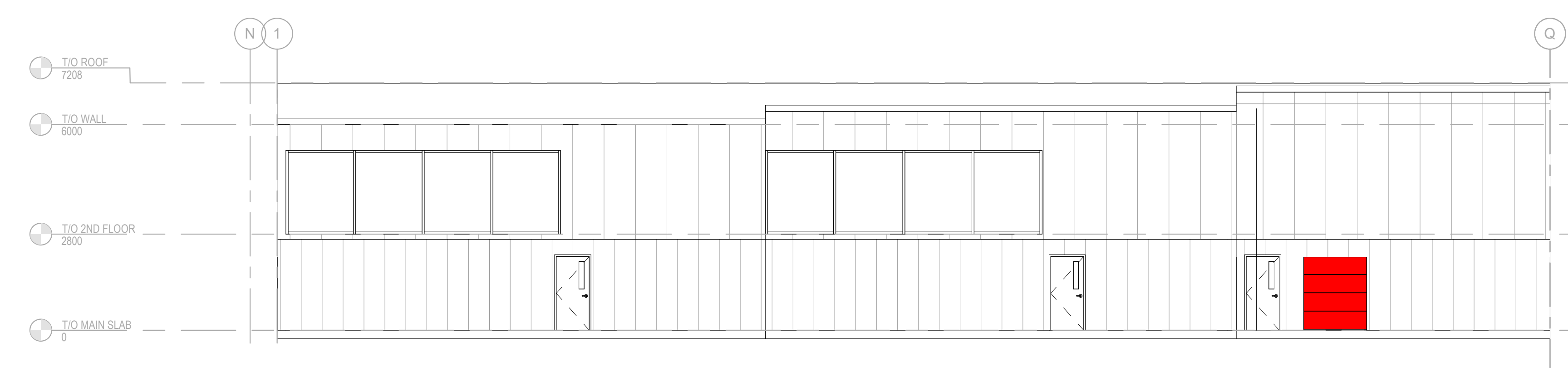

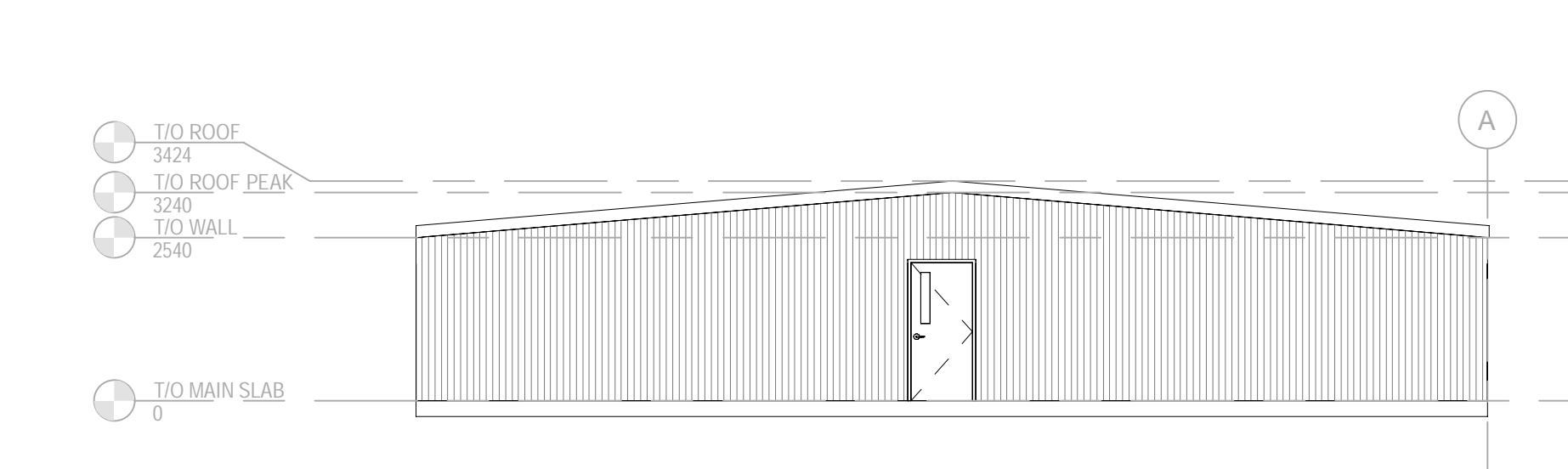
1 BUILDING B OVERALL GROUND FLOOR PLAN

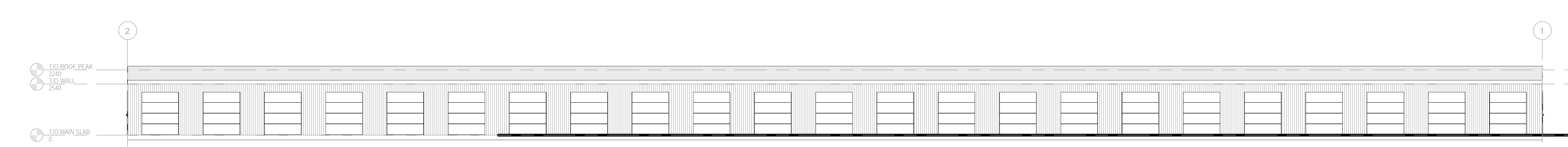

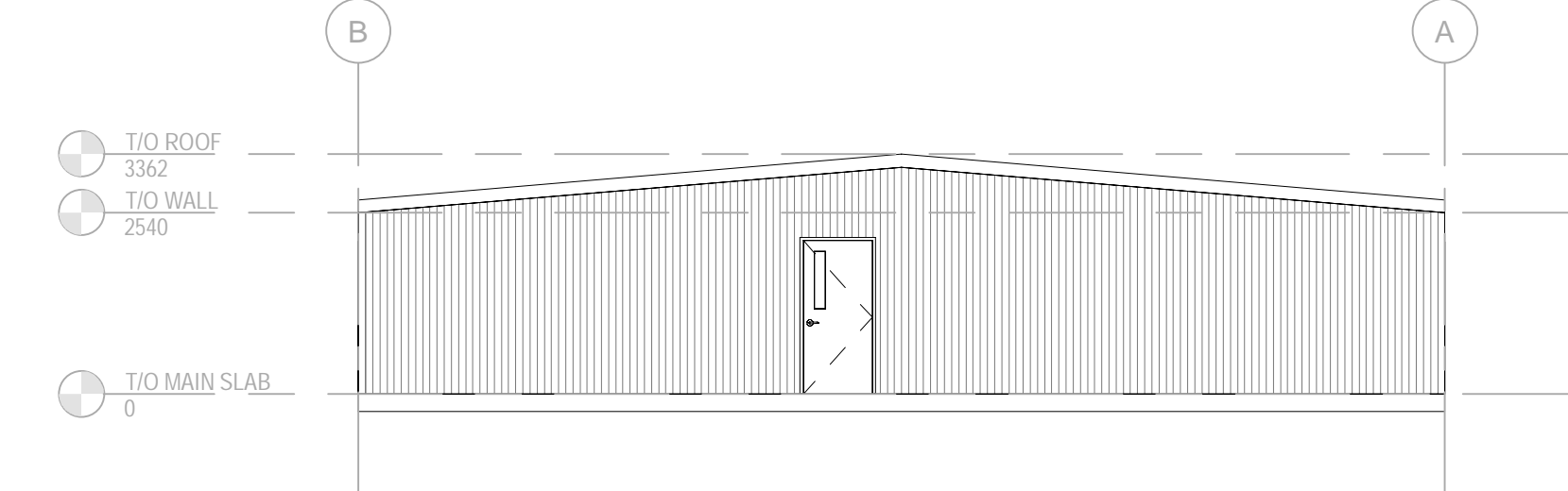
1 BUILDING C OVERALL GROUND FLOOR PLAN

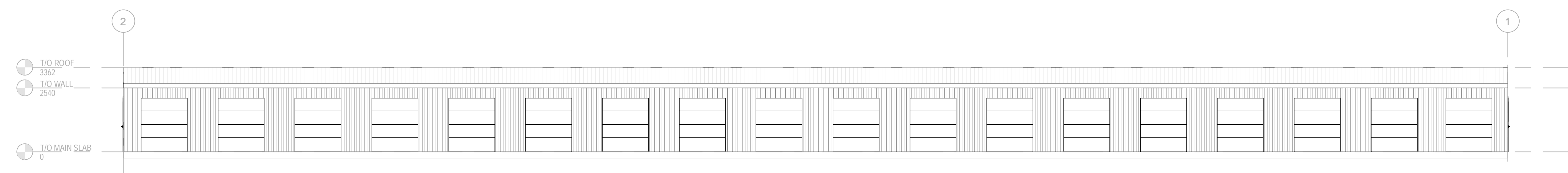

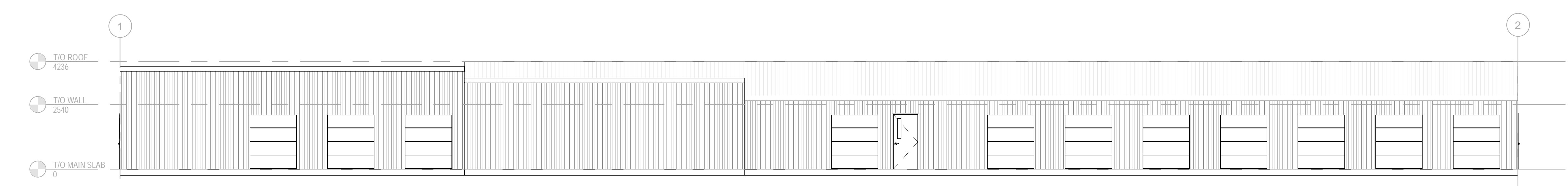

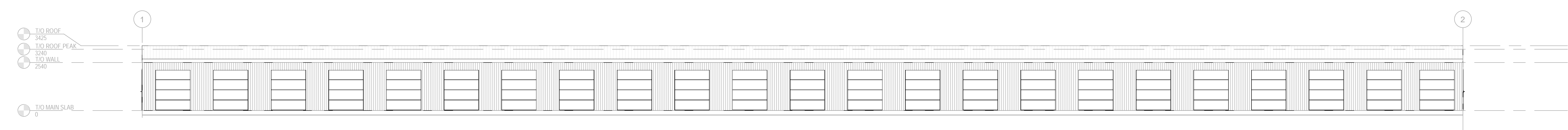
1 BUILDING E OVERALL GROUND FLOOR PLAN

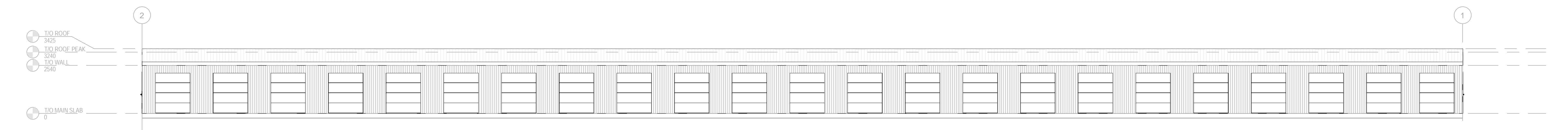

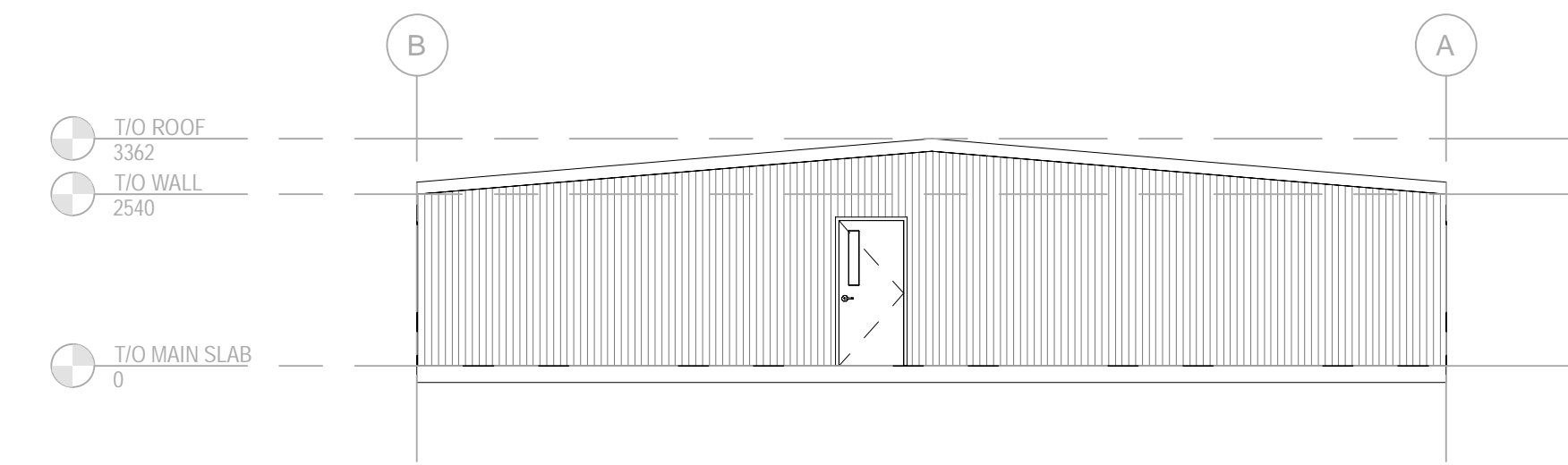
1 BUILDING F OVERALL GROUND FLOOR PLAN

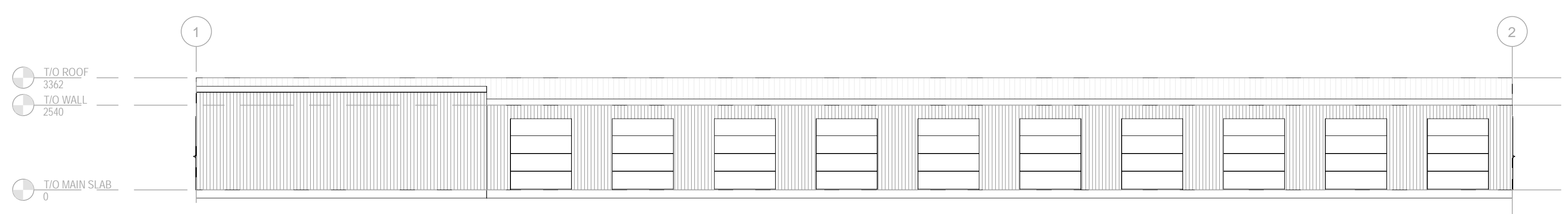

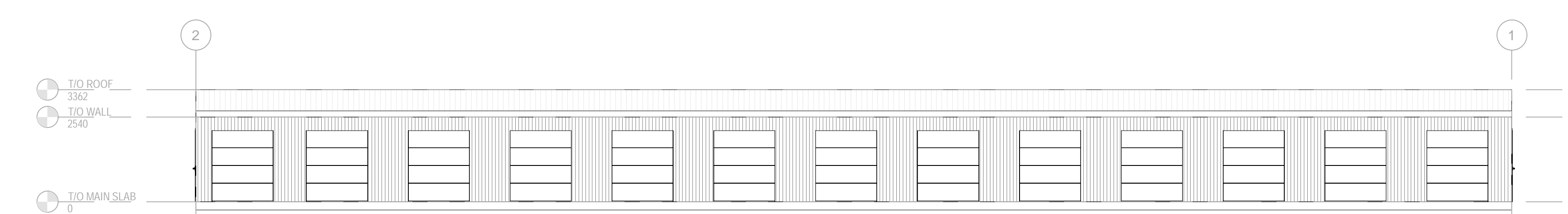
