PRUNE AT TIME OF PLANTING TO CAREFULLY REMOVE ALL DEAD, BROKEN, DAMAGED, AND INTERFERING BRANCHES. DO NOT PAINT WOUNDS PLANTING DEPTH: IN HEAVY CLAY OR POOR DRAINED SOIL ALL WOODY PLANTS TO BE PLACED SO THAT THE ROOT COLLAR IS POSITIONED 75-100MM HIGHER THAN THE SURROUNDING GRADE. PLACE TREE AT HEIGHT SO THAT ROOT COLLAR IS AT OR SLIGHTLY HIGHER THAN SURROUNDING CUT AND REMOVE ALL WIRE, ROPE, BURLAP AND TWINE FROM

AROUND THE TRUNK AND TOP THIRD OF THE ROOT BALL CONSTRUCT 75MM TOPSOIL SAUCER 150MM BEYOND THE EDGE OF THE ROOTBALL SPECIFIED PLANTING MIXTURE.


(D1) MAGLIN 1600 SERIES BIKE RACK
