Further to your request, Paterson Group (Paterson) carried out a Phase I Environmental Site Assessment (ESA) Update for the aforementioned property. This report updates a previous Phase I ESA report completed by Paterson, dated January 6, 2021. This report is intended to meet the requirements of a Phase I ESA Update, as per the MECP Standard O.Reg. 153/04, as amended, under the Environmental Protection Act. This report is to be read in conjunction with the previous report.

Site Information

The Phase I Property is vacant land. The Phase I Property is bounded by Spratt Road, Barn Swallow Private, and Stockholm Private, in the City of Ottawa, Ontario. The Phase I property is an irregular shaped lot in a GM – General Mixed-Use Zone. The property is surrounded by agricultural, institutional and residential lands. The Phase I Property is situated in a municipally serviced area. The configuration of the Phase I Property is shown on Drawing PE5128-3 - Site Plan, which is appended to this report.

Records Review

Phase I ESA Study Area Determination

A radius of approximately 250m was determined to be appropriate as a Phase I ESA Study Area for this assignment. Properties outside the 250m radius are not considered to have the potential to impact the Phase I Property, based on their separation distance.





First Developed Use Determination

Based on historical information, the Phase I Property has never formally been developed. The site was a private horse track sometime prior to 1976 until 2015, with a single associated barn and storage shed in the southeast section of the property.

Previous Engineering Reports

- *“Phase I Environmental Site Assessment, 4642 Spratt Road, Ottawa, Ontario,” prepared by Paterson Group, dated January 6, 2021.*

The Phase I Property was vacant at the time of the 2021 Phase I ESA. The results of the historical research and site assessment did not identify any potentially contaminating activities on the Phase I or surrounding properties within the Phase I Study Area. A Phase II ESA was not recommended.

Environment Canada

A search of the National Pollutant Release Inventory (NPRI) was conducted electronically on January 28, 2026. The Phase I property and adjacent properties were not listed in the NPRI database. No records of pollutant release were listed in the database for properties located within the Phase I study area.

MECP Brownfields Environmental Site Registry

A search of the MECP Brownfields Environmental Site Registry was conducted as part of this assessment for the site, neighbouring properties, and the general area of the site. No Records of Site Conditions (RSCs) were filed for the Phase I property or adjacent properties.

Areas of Natural Significance

A search for areas of natural and scientific interest situated within the Phase I study area was conducted electronically via the Ontario Ministry of Natural Resources and Forestry (OMNRF) website. The search did not identify any natural features or areas of natural significance within the Phase I study area.

Technical Standards and Safety Authority (TSSA)

The TSSA, Fuels Safety Branch in Toronto, was contacted to inquire about current and former underground/aboveground storage tanks for the subject and neighbouring properties. The TSSA response indicated that no records were identified for the subject site or neighbouring properties. The response from the TSSA is appended to this report.



City of Ottawa Old Landfill Sites

The City of Ottawa's Former Landfills online map was reviewed as part of this assessment. This map identifies 123 former landfills through the City of Ottawa's Old Landfill Management Strategy (OLMS 2004) and includes location, ownership, periods of operation and waste type for 82 sites identified as previously owned/operated either fully or in part by former municipalities and townships within the boundaries of the City of Ottawa and is updated periodically.

A review of this map on January 28, 2026, did not identify any landfill sites situated on the Phase I Property or within 250 m of the Phase I Property.

City of Ottawa Historical Land Use Inventory (HLUI)

A requisition was sent to the City of Ottawa to request information from the City's Historical Land Use Inventory database for the Phase I property as part of the 2021 Phase I ESA.

The HLUI Response was reviewed as part of the current Phase I ESA Update. The HLUI response letter indicated that no activities were associated with the subject or surrounding properties.

ERIS Database Report

A database report, prepared by ERIS (Environmental Risk Information Services) Ltd., dated December 15, 2020, was acquired and reviewed as part of the 2021 Phase I ESA. The complete ERIS report has been included in the attachments.

On-Site Records:

The ERIS report did not identify any records pertaining to the Phase I Property.

Off-Site Records:

One (1) record from Ontario Spills was identified within the study area. The listing was for a natural gas leak (18 Stockholm Private), which according to the ERIS report was a new residential subdivision at the time of the incident. The spill was located approximately 165 m away from the Phase I Property; however, it was not considered to have impacted the Phase I Property based on the type of contaminant and its distance. Two (2) pipeline incidents were reported to have occurred within the Phase I Study Area. Based on the type of contaminant and medium involved, the incidents are not considered to represent any concern to the Phase I Property. No other pertinent information was provided in the ERIS search report.



Aerial Photographs

The latest aerial image in the 2021 Phase I ESA report was from 2017. For this update, the 2025 aerial photograph, accessed via Google Earth, was reviewed.

In the 2025 aerial photograph, the Phase I Property remains vacant. Residential dwellings have been constructed in the general area of the Phase I Property. A school has been constructed to the northeast of the subject site. No other significant changes were identified with respect to the Phase I properties or the neighbouring properties since the time of the previous 2017 aerial photograph.

A copy of the 2025 aerial photograph has been appended to this report.

Water Well Records

The MECP online interactive well record mapping system was accessed on January 28, 2026, to conduct a search for all drilled wells within 250 m of the Phase I Property. No records of water wells were identified within 250 m of the Phase I Property.

Property Owner Representative Interview

Mr. Marc St. Pierre, of Claridge Homes, was interviewed as part of this update. Mr. St. Pierre was unaware of any potential environmental concerns on the subject and neighbouring properties.

Site Reconnaissance

Our site reconnaissance visit was conducted on January 28, 2026. Weather conditions were overcast with a temperature of approximately -20° C. Mr. Joshua Dempsey from the Environmental Department of Paterson Group conducted the site inspection.

In addition to the site, the uses of neighbouring properties within the Phase I Study Area were also assessed at the time of the site visit.

Exterior Assessment

There are no buildings present on the Phase I Property. It currently exists as vacant land covered in brush with an undulating topography, which could be attributed to reworked native topsoil piles from the development of the adjacent residential properties to the north and west of the Phase I Property.

The site topography was relatively level with the surrounding properties. Site drainage occurs through infiltration. No unidentified substances were observed on-site at this time. It should be noted that the Phase I Property was snow covered at the time of the site assessment.



No aboveground or underground storage tanks were observed on the subject property. No water wells were observed on the property.

No evidence of current or former railway or spur lines was observed on the subject property at the time of the site inspection. There were no unidentified substances observed on the subject site.

Neighbouring Land Use

Neighbouring land use in the Phase I Study Area is residential. Current land use within the Phase I Study Area is illustrated on Drawing: PE5128-4 – Surrounding Land Use Plan in the Figures section of this report, following the text.

Review and Evaluation of Information

Land Use History

Based on historical information, the Phase I Property has never formally been developed. The site was a private horse track sometime prior to 1976 until 2015, with a single associated barn and storage shed in the southeast section of the property.

Potentially Contaminating Activities and Areas of Potential Environmental Concern

No potentially contaminating activities (PCAs) were identified on the Phase I or surrounding properties. As a result, no APECs were identified.

Contaminants of Potential Concern

No Contaminants of Potential Concern (CPCs) were identified on the Phase I Property.

Conceptual Site Model

Geological and Hydrogeological Setting

The Geological Survey of Canada website on the Urban Geology of the National Capital Area was consulted as part of this assessment. Based on this information, bedrock in the area of the site consists of interbedded sandstone and dolomite of the March Formation, whereas the surficial geology generally consists of marine deposits, clay and silt, with an overburden thickness ranging from 10 to 15 m below the existing ground surface.

The regional topography slopes down in a southwesterly direction towards the Rideau River. The local groundwater beneath the Phase I Property is inferred to flow in a southwest direction as well.



Existing Buildings and Structures

No buildings or structures are present on the Phase I Property.

Water Bodies

The nearest named body of water is the Rideau River, located approximately 1.15 km west of the Phase I property.

Areas of Natural Significance

No areas of natural significance were identified on the Phase I Property or within the Phase I Study Area.

Drinking Water Wells

No domestic potable wells were observed on the Phase I Property nor are there expected to be any present on-site as the Phase I property has never been formally developed.

Neighbouring Land Use

Neighbouring land use in the Phase I study area consists of residential. Land use is shown on Drawing Number PE5128-4- Surrounding Land Use Plan.

Potentially Contaminating Activities and Areas of Potential Environmental Concern

As per Section 7.1 of this report, no PCAs were identified on the Phase I or surrounding properties.

No Areas of Potential Environmental Concern were identified on the Phase I property.

Assessment of Uncertainty and/or Absence of Information

The information available for review as part of the preparation of this Phase I- ESA Update is considered to be sufficient to conclude that there are no APECs on the Phase I Property.

A variety of independent sources were consulted as part of this assessment, and as such, the conclusions of this report are not affected by uncertainty which may be present with respect to the individual sources.

Conclusions

Based on the results of this Phase I ESA Update, **it is our opinion, that a Phase II Environmental Site Assessment is not required for the property.**



Statement of Limitations

This Phase I - Environmental Site Assessment Update report has been prepared under the supervision of a Qualified Person in general accordance with the agreed scope-of-work and O.Reg. 153/04. The conclusions presented herein are based on information gathered from a historical review and field inspection program.

The findings of the Phase I ESA Update are based on a review of readily available geological, historical and regulatory information and a cursory review made at the time of the field assessment. The historical research relies on information supplied by others, such as local, provincial, and federal agencies and was limited within the scope-of-work, time, and budget of the project herein.

Should any conditions be encountered at the Phase I Property and/or historical information that differ from our findings, we request that we be notified immediately in order to allow for a reassessment.

This report was prepared for the sole use of Claridge Homes. Permission and notification from Claridge Homes and this firm will be required to release this report to any other party.

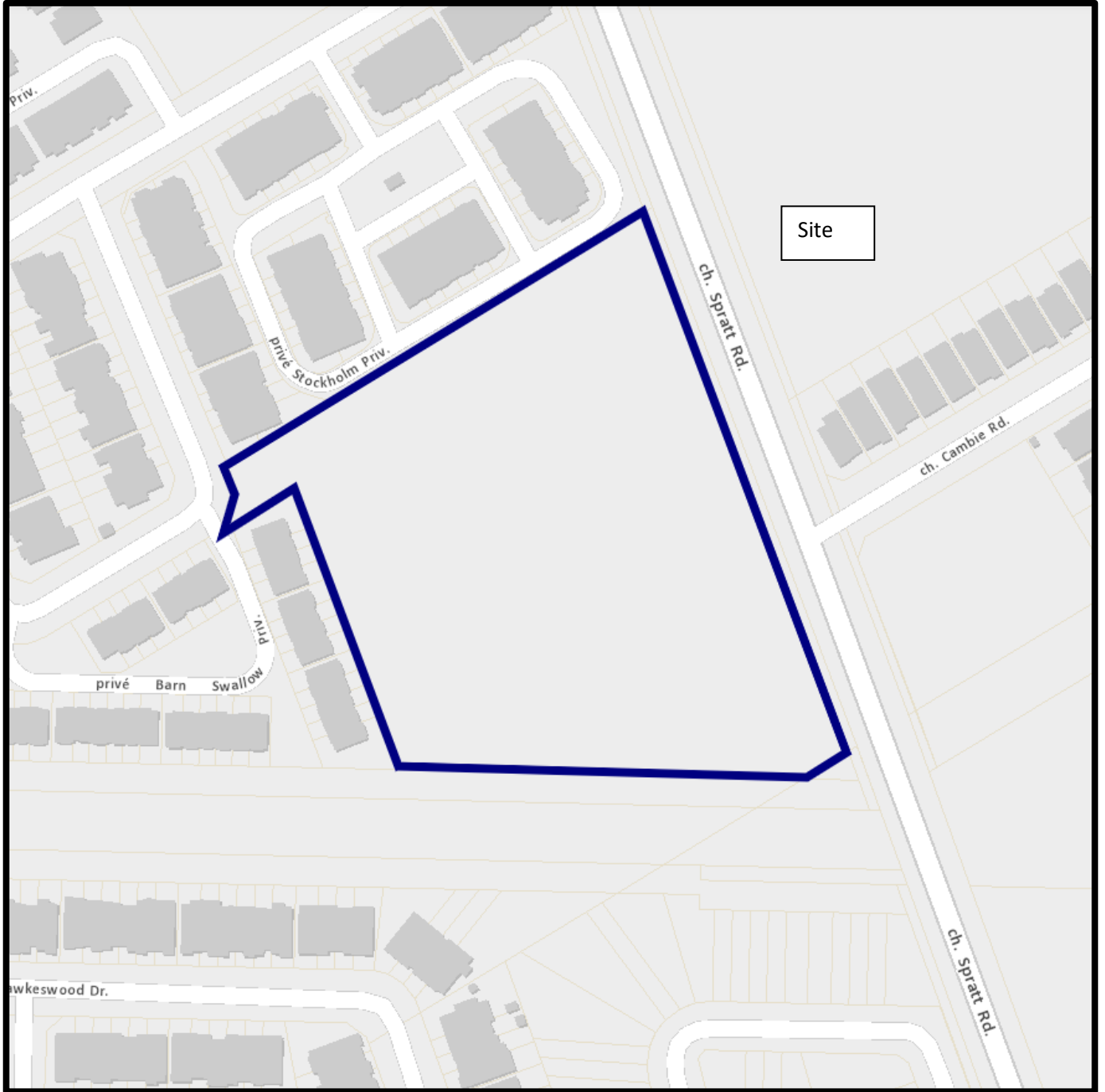

KEY PLAN

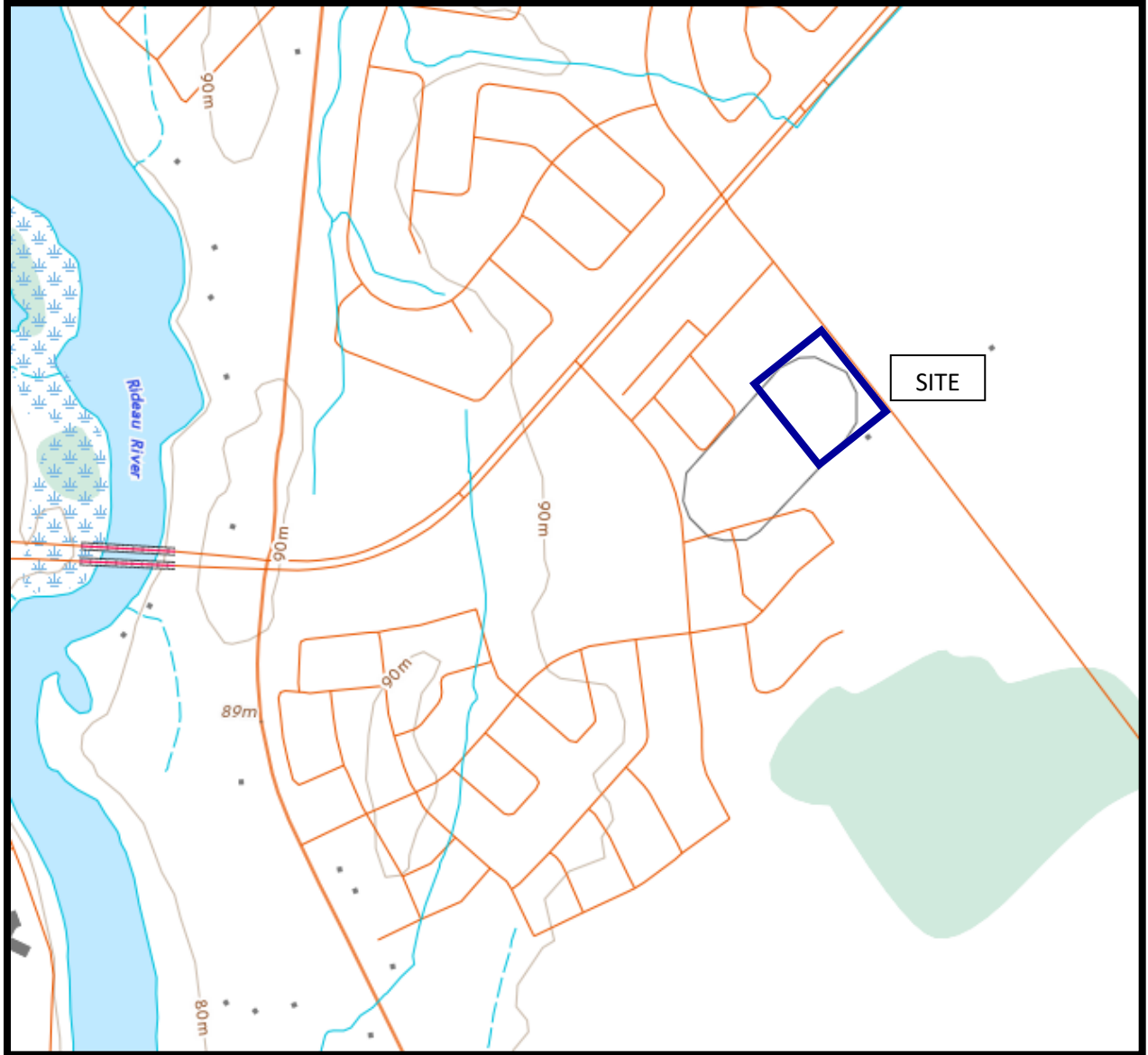
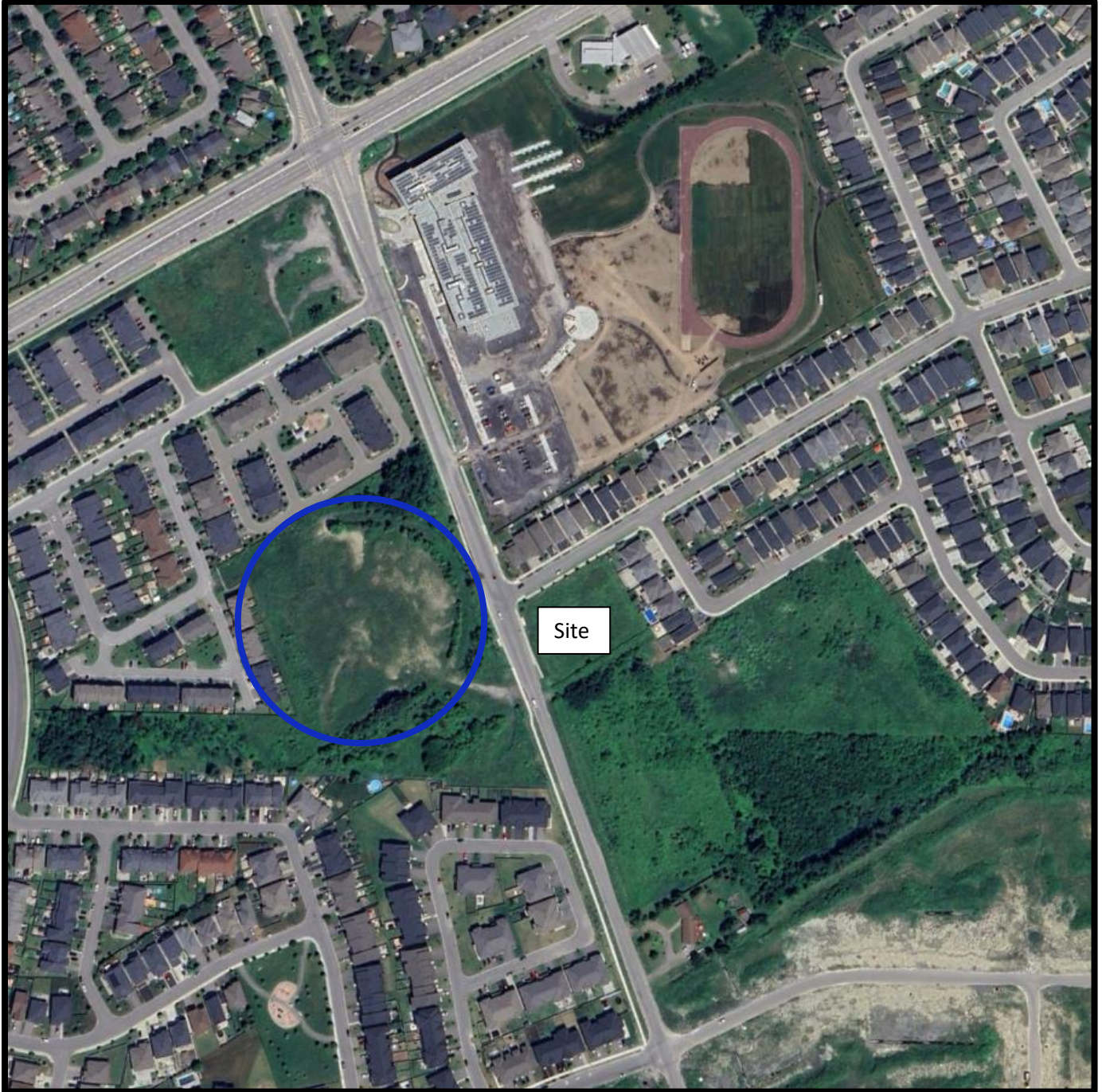
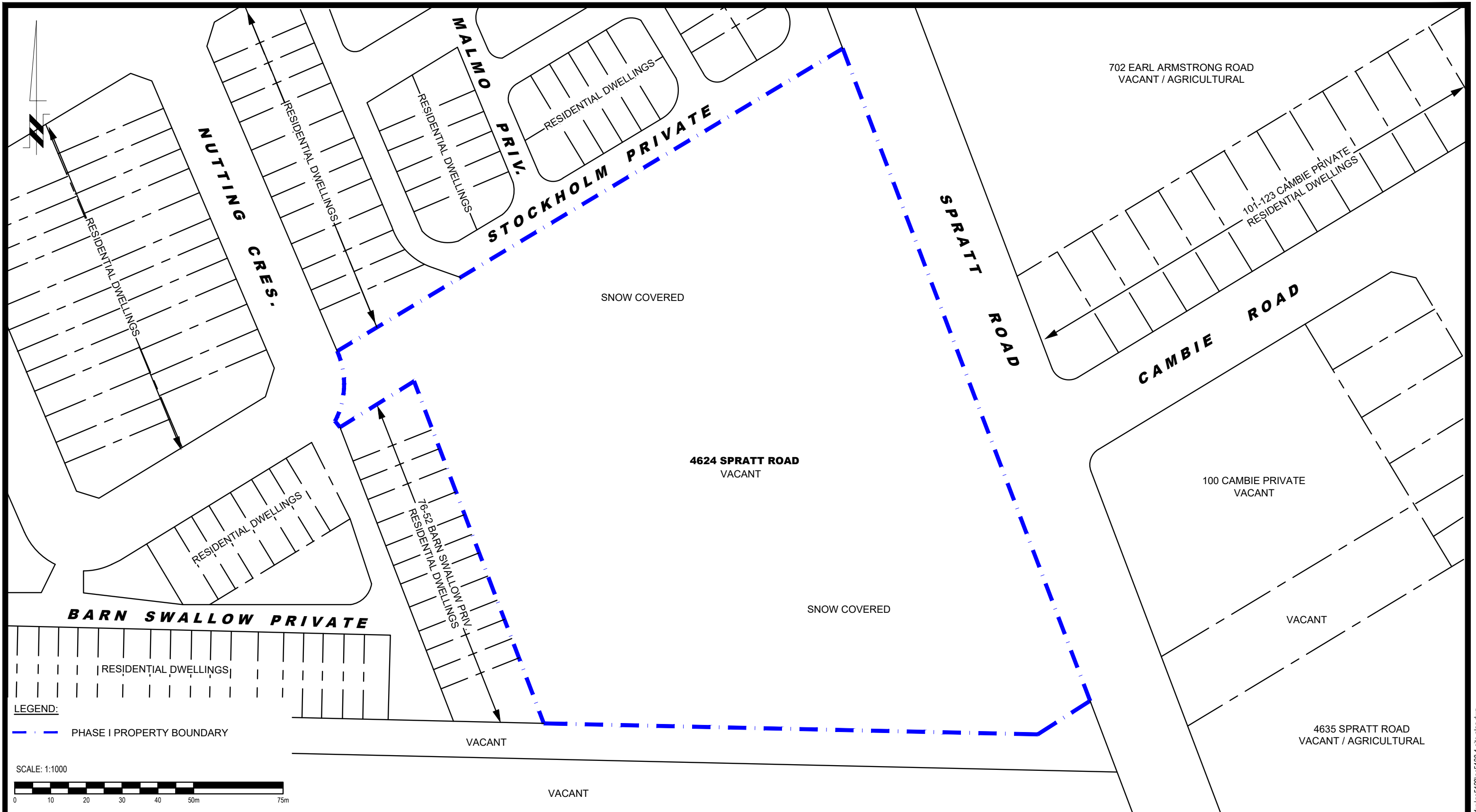

In June 1991, the Ontario Ministry of Environment, Waste Management Branch, published the "June 1991 Waste Disposal Site Inventory", of all known active and closed waste disposal sites as of October 30th, 1990. For each "active" site as of October 31st 1990, information is provided on site location, site/CA number, waste type, site status and site classification. For each "closed" site as of October 31st 1990, information is provided on site location, site/CA number, closure date and site classification. Locations of these sites may be cross-referenced to the Anderson database described under ERIS's Private Source Database section, by the CA number.

Water Well Information System:

This database describes locations and characteristics of water wells found within Ontario in accordance with Regulation 903. It includes such information as coordinates, construction date, well depth, primary and secondary use, pump rate, static water level, well status, etc. Also included are detailed stratigraphy information, approximate depth to bedrock and the approximate depth to the water table.

Definitions

Database Descriptions: This section provides a detailed explanation for each database including: source, information available, time coverage, and acronyms used. They are listed in alphabetic order.

Detail Report: This is the section of the report which provides the most detail for each individual record. Records are summarized by location, starting with the project property followed by records in closest proximity.

Distance: The distance value is the distance between plotted points, not necessarily the distance between the sites' boundaries. All values are an approximation.

Direction: The direction value is the compass direction of the site in respect to the project property and/or center point of the report.

Elevation: The elevation value is taken from the location at which the records for the site address have been plotted. All values are an approximation. Source: Google Elevation API.

Executive Summary: This portion of the report is divided into 3 sections:

'Report Summary'- Displays a chart indicating how many records fall on the project property and, within the report search radii.

'Site Report Summary'-Project Property'- This section lists all the records which fall on the project property. For more details, see the 'Detail Report' section.

'Site Report Summary-Surrounding Properties'- This section summarizes all records on adjacent properties, listing them in order of proximity from the project property. For more details, see the 'Detail Report' section.

Map Key: The map key number is assigned according to closest proximity from the project property. Map Key numbers always start at #1. The project property will always have a map key of '1' if records are available. If there is a number in brackets beside the main number, this will indicate the number of records on that specific property. If there is no number in brackets, there is only one record for that property.

The symbol and colour used indicates 'elevation': the red inverted triangle will dictate 'ERIS Sites with Lower Elevation', the yellow triangle will dictate 'ERIS Sites with Higher Elevation' and the orange square will dictate 'ERIS Sites with Same Elevation.'

Unplottables: These are records that could not be mapped due to various reasons, including limited geographic information. These records may or may not be in your study area, and are included as reference.
