SITE DESCRIPTION:
THE SITE IS OF LOW ENVIRONMENTAL VALUE, DUE TO THE HEALTH AND THE SPECIES. THERE ARE 89 TREES LOCATED ON PRIVATE PROPERTY, AND 2 LOCATED ON THE ADJACENT PROPERTY TO THE SOUTH WITHIN 1-2M OF THE PROPERTY LINE. OUT OF THE 91 TREES THAT HAVE BEEN INVENTORIED 18 ARE DISTINCTIVE TREES (COMBINED DBH OVER 50cm). ALONG THE EASTERN PROPERTY LINE THERE ARE RUSSIAN OLIVE TREES THAT SHOULD BE REMOVED AS PART OF PHASE 1 WORKS. THERE ARE 13 DEAD TREES THAT SHOULD BE REMOVED AS PART OF PHASE 1 WORKS, 8 OF WHICH ARE LOCATED OUTSIDE THE WORK LIMITS OF PHASE 1. THERE IS AN ARTIFICIAL POND LOCATED IN THE COURTYARD OF THE EXISTING HOTEL TO REMAIN, THERE IS NO NATURALLY OCCURRING SURFACE WATER, AND NO STEEP SLOPES ON THE SITE.
