## **Executive Summary**

McIntosh Perry was retained by Ms. Gabriela Godinez-Laverty of 2851944 Ontario Inc. (Client) to conduct a Phase One Environmental Site Assessment (ESA), Geotechnical Investigation and Foundation Design Recommendations for the property located at 1806 Scott Street, Ontario ("the Site"). It is our understanding that the site is currently occupied by a residential dwelling and will be redeveloped to contain a four-storey structure with a basement level, and no underground parking. The building is proposed to be a mixed-use rental apartment building.

The Phase One ESA will be completed by McIntosh Perry in general accordance with the requirements of Ontario Regulation (O.Reg.) 153/04 as amended, and the Guide for Completing Phase One Environmental Site Assessments under Ontario Regulation 153/04 (Ontario Ministry of the Environment, June 2011), as amended. It is understood that the property is currently occupied by a residential dwelling. The proposed future development as a mixed-use rental apartment does not represent a change to a more sensitive land use; therefore, a Record of Site Condition (RSC) will not be required.

This Phase One ESA has been prepared in general accordance with the requirements of Ontario Regulation (O.Reg.) 153/04 as amended. This report is also in general compliance with "Phase I Environmental Site Assessment", Canadian Standards Association (CSA) standard CSA Z768-01, reaffirmed 2022.

Based on historical information (aerial photos, fire insurance plans) the Site appears to have been first developed as a residential dwelling between 1948 and 1951, with a subsequent addition made in approximately 2002.

A total of three (3) potentially contaminating activities (PCAs) were identified for the Phase One Property and Phase One Study Area. Of the 3 PCAs identified, no PCAs were deemed to represent areas of potential environmental concern (APECs). Table 4 presents a summary of the identified PCAs for the Phase One Property and Phase One Study Area.

Based on the above-noted information, a Phase Two ESA is not recommended for the Site.

## 1.0 INTRODUCTION

McIntosh Perry was retained by Ms. Gabriela Godinez-Laverty of 2851944 Ontario Inc. (Client) to conduct a Phase One Environmental Site Assessment (ESA), Geotechnical Investigation and Foundation Design Recommendations for the property located at 1806 Scott Street, Ontario ("the Site"). It is our understanding that the site is currently occupied by a residential dwelling and will be redeveloped to contain a four-storey structure with a basement level, and no underground parking. The building is proposed to be a mixed-use rental apartment building.

The Phase One ESA will be completed by McIntosh Perry in general accordance with the requirements of Ontario Regulation (O.Reg.) 153/04 as amended, and the Guide for Completing Phase One Environmental Site Assessments under Ontario Regulation 153/04 (Ontario Ministry of the Environment, June 2011), as amended. It is understood that the property is currently occupied by a residential dwelling. The proposed future development as a mixed-use rental apartment does not represent a change to a more sensitive land use; therefore, a Record of Site Condition (RSC) will not be required.

The Site location is shown on Figure 1 (Site Location). The Site layout and features, including on-Site land use, are shown on Figure 2 (Site Layout).

## 1.1 Phase One Property Information

## 1.1.1 Property Identification

The legal description of the Site is as follows:

#### 1.1.2 Property Ownership and Contact Details

## 1.1.3 Current and Proposed Future Uses

The Site is currently occupied by a two-story residential dwelling with paved parking areas at the north and east sides, with a grassed back yard that is completely fenced in. It is proposed that the residential dwelling be converted into a four-storey mixed-used rental apartment building with a basement level, and no underground parking.

## 1.2 Surrounding Land Use

The Site is bounded by residential units on the east, west, and south sides, and a transit line with residential units to the north. Surrounding land use within the Phase One ESA study area is predominantly residential with some commercial land use.

## 2.0 SCOPE OF INVESTIGATION

A Phase One ESA is a preliminary environmental screening tool designed to provide a qualitative assessment of the environmental condition of a site, based on a desktop review of available documentation pertaining to the site and observations made during a site visit. Sampling and chemical analysis of soils, groundwater, and/or other materials/substances are beyond the scope of work for a Phase One ESA.

The Phase One ESA has been prepared in general accordance with the requirements of the following legislation:

Ontario Regulation (O. Reg.) 153/04 - Records of Site Condition (as amended).

The report is also in general compliance with:

 "Phase I Environmental Site Assessment", Canadian Standards Association (CSA) standard CSA Z768-01, Reaffirmed 2022.

A designated substances survey was not completed as part of the current investigation.

The subject property is not an 'Enhanced Investigation Property' as defined in O.Reg. 153/04 (as amended).

## 3.0 RECORDS REVIEW

#### 3.1 General

## 3.1.1 Phase One Study Area Determination

The Phase One Study Area includes the following properties:

- The Site; and
- All properties within approximately 250 m of the Site boundary (Phase One Study Area).

The Phase One ESA Study Area, including surrounding land uses, is shown on Figure 3: Study Area & Surrounding Land Use.

### 3.1.2 First Developed Use Determination

Based on a review of aerial photographs, insurance reports, and historical information, the Site appears to have been first developed with a residential building between 1948 and 1951. Based on historical aerial photographs, an addition was constructed in 2002 to the existing residential unit on the southeast corner of the property, along with a new driveway.

#### 3.1.3 Fire Insurance Plans

The following Fire Insurance Plans (FIPs) were reviewed as part of this Phase One ESA:

#### 3.1.3.1 1915 Fire Insurance Plans

Based on the age of the FIP, features at the Site and surrounding areas are hard to discern. It appears that several parcels of land exist, however the land use is unknown. A railway is present immediately north of the Site. No PCAs were noted based on this map.

#### 3.1.3.2 1948 Fire Insurance Plans

The Site appears to be developed by a dwelling (inferred residential). A parking lot with a building for auto storage is additionally noted immediately southwest of the main dwelling. Surrounding properties consist mainly of residential and some commercial land use. The Canadian Pacific Railway is located to the north of the Site. Gasoline service stations are located further south and southeast of the Site. No PCAs were identified based on this map.

#### 3.1.3.3 1965 Fire Insurance Plans

The Site is occupied by one residential dwelling. Surrounding properties consist mainly of residential and commercial properties. The Canadian Pacific Railway is located to the north of the Site.

A copy of the Opta response is provided in Appendix A.

## 3.1.4 Insurance Reports

No Insurance Reports were reviewed as part of this Phase One ESA report.

#### 3.1.5 Chain of Title

At the time of this report, a Chain of Title has not been completed. McIntosh Perry is of the opinion that the lack of a Chain of Title search is not an impediment for the Phase One ESA as sufficient information and documentation has been obtained and reviewed to formulate a reasonable understanding for the Phase One property.

## 3.1.6 Previous Environmental Reports

Mcintosh Perry was not provided with any environmental reports previously prepared for the Site.

## 3.1.7 City Directories

City Directories were searched for the Site and surrounding properties for the years between 1941 to 2011. Availability of city directories was somewhat limited by the COVID-19 pandemic resulting in restricted access to library facilities. The following tables summarized the city directory search results for the Site:

The City Directory search did not identify any additional PCAs or APECs on the Site.

City directory records for surrounding properties surrounding the Site began in 1946 and were all residential properties. City directory search results are appended to this report as Appendix B.

## 3.2.2 Database Findings Relevant to the Phase One ESA

The databases searched by ERIS contained the following information pertaining to the Site:

No records were found in the selected databases for the project property.

The following records were returned for properties within the Phase One Study Area:

- Two (2) Certificates of Approval (CA);
- Three (3) Commercial Fuel Oil Tanks (CFOT)
- One (1) Delisted Fuel Tank (DTNK);

- One (11) Environmental Compliance Approval (ECA);
- Three (3) ERIS Historical Searches (EHS);
- Two (2) O.Reg. 347 Waste Generator Summaries (GEN);
- One (1) Fuel Oil Spill and Leak record (INC);
- One (1) Pesticide Registry records (PES);
- Three (3) Pipeline Incident records (PINC);
- Four (4) Ontario Spills records (SPL); and,

• Six (6) WWIS records (WWIS).

Relevant information from the ERIS report is summarized as follows:

53 Gould Street, located approximately 37 m east (inferred up/cross-gradient) of the Site

 One commercial fuel oil and one delisted fuel tank record indicated that the property listed under James Blaney houses a 1100 L Single Wall underground fuel storage tank (UST), installed 1975 and delisted 7/5/2009.

Based on the commercial fuel oil and the delisted fuel tank records associated with this property, it is MP's opinion that the hazardous wastes generated at this property represent a PCA. Due to the age of the record and distance from the site this record does not constitute an APEC in relation to the Site. Additionally, it appears this property was redeveloped between 2012 and 2014; after the delist date.

1790 Scott Street, located approximately 62 m east northeast (inferred cross/up-gradient) of the Site

An Ontario Spill record indicated that a 4-L waste motor oil spill occurred in 1993. The record indicated
that the spill had been cleaned, and possible soil contamination was anticipated. Based on the location
of the spill and time in which this spill occurred, it is MP's opinion that this record does not constitute
an APEC in relation to the Site.

327 Island Park Drive, located approximately 156 m south (inferred up/cross-gradient) of the Site

• One fuel oil spills and leaks record indicated ½" pipeline hit damage to a regulator head on a fuel riser distribution pipeline. No fuel spill quantity or environmental impact was recorded. Based on the location of the spill and its severity, it is MP's opinion that the spill does not represent a PCA or APEC in relation to the Site.

Island Park Drive and Scott Street, located approximately 205 m west southwest (inferred cross/up-gradient) of the Site

 An Ontario spills record under Hydro Ottawa Limited indicated that a 5-L hydraulic oil leak occurred in 2011. The record indicated that the spill had been cleaned, and the environmental impact has been listed under other impacts. Based on the location of the site, the small volume of the spill and the down-gradient location from the site, it is MP's opinion that the spill represents a PCA, however, it does not represent an APEC in relation to the Site.

1786 Scott Street, located approximately 77 m east northeast (inferred cross/up-gradient) of the Site

 One pipeline incident record under Enbridge Gas Inc. indicated that unknown pipeline damage occurred in 2020. No fuel spill quantity or environmental impact was recorded. Based on the location of the spill and its severity, it is MP's opinion that the spill does not represent a PCA or APEC in relation to the Site.

## 3.2.3 MECP Freedom of Information Request

In order to identify any previous environmental reports concerning the subject property, a MECP Freedom of Information (FOI) request was submitted by McIntosh Perry, on July 19<sup>th</sup>, 2022 (the regular turn around time is one to two months).

A response was received on August 9<sup>th</sup>, 2022, which indicated that no records were located in response to the original request. Accordingly, the file has been closed.

MECP correspondence is provided in Appendix D of this report.

## 3.2.4 TSSA Information Request

An FOI request was submitted to the Technical Standards and Safety Authority (TSSA) on July 19, 2022. A response was received on July 19, 2022, in which TSSA indicated that no fuel storage tank records were returned for 1806 Scott Street; this is consistent with the ERIS search results.

A copy of the TSSA response is provided in Appendix D.

## 3.2.5 Historic Land Use Inventory Request

A request for information from the Historic Land Use Inventory (HLUI) records was completed on December 12, 2022. A response was received on January 17, 2023. The results of the HLUI were reviewed, and no information was revealed which would result in environmental impacts on the Site.

A copy of the HLUI correspondence is included in Appendix D.

## 4.0 PHYSICAL SETTING

## 4.1.1 Aerial Photographs and Satellite Images

Table 1 describes observations about current and historical land use for the Site and surrounding properties that were noted during a review of aerial photos, included in Appendix E. Current land uses are included on Figure 3.

A review of the above aerial photographs did not indicate any additional PCAs on the Site or within the Study Area.

## 4.1.2 Topography

Elevation at the Site is approximately 62 m above sea level (masl). The topography is generally flat, with regional topography sloping downward to the northwest towards the Ottawa River (see Figure 4).

## 4.1.3 Hydrology

The Site occurs within the Ottawa River watershed. The Ottawa River is located approximately 850 m northwest of the Site at its closest point. Site drainage is presumed to consist of overland flow to municipal sewers along Scott Street.

## 4.1.4 Geology

## 4.1.4.1 Surficial Geology

Geological maps of the area classify the overburden at the Site as silt to silty sand textured glacial till on Paleozoic terrain (OGS, 2017).

### 4.1.4.2 Bedrock Geology

Geological maps of the area classify the bedrock under the Site as predominantly limestone, which appears to be fairly shallow ranging in depth from 0.3 m to 2.3 m (OGS, 2017).

## 4.1.5 Hydrogeology

The Site occurs within the Ottawa River watershed. Groundwater likely flows northwest based on local topography as well as the location of the Ottawa River which flows northeast.

#### 4.1.6 Fill Materials

No fill material was observed at the Site during the Site reconnaissance on August 12<sup>th</sup>, 2022.

#### 4.1.7 Water Bodies and Areas of Natural Significance

The closest permanent waterbody is the Ottawa River, located approximately 850 m northwest of the Site.

When completing a Phase One ESA, considerations are made for the following MNRF-maintained areas of natural significance:

- Provincial Parks and conservation reserves:
- Areas of Natural and Scientific Interest (ANSIs);
- Provincially Significant Wetlands (PSWs);
- Areas identified by MNRF as significant habitat of a threatened or endangered species or areas of habitat of a species classified under section 7 of the Endangered Species Act; and,
- Areas set apart under the Wilderness Areas Act.

No areas of natural significance were observed within the Phase One Study Area.

## 4.1.8 Well Records

McIntosh Perry performed a well record search utilizing the ERIS Water Well Information System data (based on MECP GIS data). Six (6) well records from within the Phase One Study Area were returned from this search; none of the well records were located on-Site.

## 4.1.9 Site Operating Records

Site operating records were not available for the Site.

## 5.0 INTERVIEWS

McIntosh Perry personnel conducted an interview with Mr. Joe Marano, Property Manager for the Site, to obtain information about the subject property pertaining to items of actual and/or potential environmental concern. Information collected during this interview was used to corroborate data from other sources, and is presented in Appendix F.

The information obtained from the interview is summarized as follows:

Note that statements made by those interviewed were not made categorically and are limited to personal knowledge of, and experience with, the subject property. The significance of environmental concerns that have been identified by other methods was not reduced based on the interview statements.

## 6.0 SITE RECONNAISSANCE

The objectives of the site reconnaissance were as follows:

- To identify potential environmental concerns associated with current and past uses of the Site;
- To identify Potentially Contaminating Activities (PCAs) on, in, or under the Site;
- To identify, as practical, current and past uses, activities, and PCAs in the vicinity of the Site; and,
- To identify details of potential contaminant pathways on, in, or under the Site and potential environmental concerns and contaminants of potential concern.

McIntosh Perry had open and ready access to all interior and exterior areas of the Site during the Site visit.

## 6.1 General Requirements

McIntosh Perry conducted the Site reconnaissance on August 12<sup>th</sup>, 2022 (from approximately 12:00 pm to 1:00 pm). Rebecca Leduc of McIntosh Perry inspected all areas of the Site and observed other properties in the Study Area from publicly accessible locations.

Weather conditions at the time of the Site visit were clear and sunny with a temperature of approximately 25 degrees Celsius.

The Site is not considered an Enhanced Investigation Property under the requirements of O.Reg. 153/04. The Site is currently occupied by a multi-tenant residential building. The building is currently owned by 2851944 Ontario Inc. Surrounding land use is primarily residential. Land use in the vicinity is shown on Figure 3.

Photographs of the Site are included in Appendix G. A brief description is included with each photograph, including location and orientation where applicable.

Field assessment and reporting was conducted by Rebecca Leduc, M.Sc., of McIntosh Perry. Rebecca has conducted various Phase I/One and II/Two ESAs for residential and commercial properties across Ontario.

Senior review for this report was provided by Meghan Coyle, P.Geo., Meghan has over 10-years experience in undertaking and reporting Phase I/One and II/Two ESAs for residential, commercial and institutional sites for public and private sector clients throughout Ontario. Meghan is a Qualified Person (QP) under O.Reg. 153/04.

McIntosh Perry is licensed to practice engineering and geoscience in the Province of Ontario. McIntosh Perry holds Certificates of Authorization with the Professional Engineers of Ontario (PEO) and Professional Geoscientists Ontario (PGO) and is a full member of the Association of Consulting Engineering Companies (ACEC).

## 6.2 Specific Observations at the Phase One Property

## 6.2.1 Structures and Other Improvements

The Site is currently occupied by a two-storey residential dwelling with paved parking areas at the north and east sides, with a grassed back yard that is completely fenced in. No other structures or improvements are present on the Site.

#### 6.2.2 Below Ground Structures

No below ground structures were observed.

### 6.2.3 Storage Tanks

No above-ground storage tanks were observed during the Site visit. Additionally, no evidence of underground storage tanks were noted during the Site visit.

Propane storage tanks were located within the backyard on the deck, closest to a barbeque. No issues were noted with respect to these propane tanks.

### 6.2.4 Lead containing Paint

Due to the age of the building, it is likely that the older paint coating surfaces may contain lead; analytical testing would be required to confirm this.

#### 6.2.5 Hazardous Materials

Cleaning chemicals are presumed to be present within the residential units, used for general cleaning purposes. No other hazardous materials were identified.

#### 6.2.6 Potable and Non-Potable Water Sources

The Site is serviced by the City of Ottawa municipal water distribution system. No potable water wells were encountered on-Site or within the Phase One Study Area.

## 6.2.7 Underground Service Trenches

Underground service trenches for water and storm/sanitary sewer are interpreted to run between the building and Scott Street, Rockhurst Street, and Oakdale Avenue.

#### 6.2.8 Exit and Entry Points

All exit and entry points to the Site were inspected. No concerns were identified.

#### 6.2.9 Existing and Former Heating Systems

The Site is currently heated by a mix of natural gas and electric heaters within individual tenant units.

### 6.2.10 Cooling Systems

The residential units are cooled via air conditioning system. An air conditioner unit was located along the eastern side of the building,

## 6.2.11 Drains, Pits, and Sumps

No drains, pits, or sumps were observed during the Site visit.

#### 6.2.12 Unidentified Substances

No unidentified substances were observed at the Site.

### 6.2.13 Stains and/or Corrosion Near Drains, Pits, and Sumps

No staining was observed at the Site.

#### 6.2.14 Well Details

No wells were observed at the Site.

### 6.2.15 Details of Sewage Works

The Site is serviced by the City of Ottawa sanitary sewer system. No private sewage systems are present on-Site.

#### 6.2.16 Ground Surface Details

The building occupies the northeast/northwest footprint for the property. A grassed backyard and two outdoor decks are located to the south of the building on-Site, as well as a paved parking lot located to the northwest of the Site building.

## 6.2.17 Current and Former Railway Lines

No current or former railway lines were encountered at the Site or adjacent properties.

## 6.2.18 Staining to Soil, Vegetation, or Pavement

No staining to the soil or vegetation was identified at the time of the Site visit. Minor staining was observed within the paved parking area, likely associated with drippings from the cars parked on-Site and de-icing salt impacts.

## 6.2.19 Stressed Vegetation

No vegetation, stressed or otherwise, was observed at the Site.

#### 6.2.20 Fill and Debris

No areas of fill placement were observed at the Site.

## 6.2.21 Mould

No mould-like substances were observed at the Site.

#### 6.2.22 Asbestos-containing materials

Some potential asbestos containing materials were observed including drywall, drywall joint compound, and carpet mastic.

## 6.2.23 Generators and other large mechanical equipment

No generators or large mechanical equipment was observed during the Site visit.

## 6.3 Surrounding Properties

Surrounding land use in the vicinity of the Site generally consisted of the following:

- North Scott Street followed by a Transitway and additional residential properties;
- South Residential properties;
- East Rockhurst Street followed by residential properties; and,
- West Residential properties followed by Oakdale Avenue.

## 7.0 REVIEW AND EVALUATION OF INFORMATION

The following sections provide a review, evaluation and an interpretation of the information from the records review, interviews and site reconnaissance.

## 7.1 Current and Past Uses of Phase One Property

The Site is currently occupied by a two-storey residential dwelling with paved parking areas at the north and east sides, with a grassed back yard that is completely fenced in. Based on a review of aerial photographs and fire insurance plans, the present-day Site building was constructed on-Site in approximately 1948-1951, with an addition in 2002. Prior to 1958, the Site was vacant. The residential building is considered to be the first developed use of the Site.

## 7.2 Potentially Contaminating Activities

A total of 3 PCAs were identified at the Site and within the Phase One ESA Study Area. As summary of identified PCAs is presented in Table 4 below.

## 7.3 Areas of Potential Environmental Concern (APEC)

Of the 3 PCAs identified for the Phase One Property and Phase One Study Area, none of these PCAs were deemed to represent APECs.

## 7.4 Phase One Conceptual Site Model

This Phase One Conceptual Site Model is prepared as part of a Phase One Environmental Site Assessment (Phase One ESA) for the Phase One Property identified in Section 1.1.1 of this report, addressed as 1806 Scott Street, Ottawa, Ontario (hereinafter referred to as the "Phase One Property" or the "Site"). A Site Location Plan is presented on Figure 1 in Appendix A.

The Site is a mainly rectangular shaped and is approximately 0.06 hectares in size, located in the downtown portion of the city of Ottawa. Based on the records review, the Site appears to have been first developed with a residential dwelling in approximately 1948-1951, with an addition in 2002. It is our understanding that the residential dwelling is to be converted into a four-storey mixed-used rental apartment building with a basement level, and no underground parking.

The legal description of the Site is as follows:

Land use at the Site is residential.

## 7.4.1 Areas Where Potentially Contaminating Activities Have Occurred

A total of 3 PCAs were identified for the Phase One ESA Property and surrounding properties within the Phase One Study Area based on the records review.

#### 7.4.2 Areas of Potential Environmental Concern

Of the 3 PCAs identified for the Phase One Study area, none were identified as representing APECs.

#### 7.4.3 Contaminants of Potential Concern

No contaminants of concern were identified with respect to the Site.

#### 7.4.4 Potential for Underground Utilities to Affect Contaminant Distribution and Transport

In general, there is the potential for underground service trenches to serve as preferential contaminant transport pathways.

## 7.4.5 Geological and Hydrogeological Information

Geological maps of the area classify the overburden at as silt to silty sand textured glacial till on Paleozoic terrain (OGS, 2017).

Geological maps of the area classify the bedrock under the Site as predominantly limestone, which appears to be fairly shallow ranging in depth from 0.3 m to 2.3 m (OGS, 2017).

The Site occurs within the Ottawa River watershed. The Ottawa River is located approximately 850 m northwest of the Site at its closest point. Site drainage is presumed to consist of overland flow to municipal sewers along Scott Street.

## 7.4.6 Uncertainty or Absence of Information

No uncertainty or absence of information noted in the Phase One ESA is considered to have the potential to affect the validity of this conceptual site model.

## 8.0 CONCLUSIONS

Based on a review of historical information, the following Potentially Contaminating Activities were identified within the Phase One Study Area:

- A historical spill located approximately 62 m northeast of the Site at 1790 Scott Street, as well as at the intersection of Island Park Drive and Scott Street (205 m west);
- Historical presence of one commercial fuel oil tank and delisted fuel tank at 53 Gould Street, located approximately 37 m east of the Site; and

Due to the separation distances, and/or down/cross gradient locations of the properties, and time in which the spills occurred in relation to the Site, the PCAs identified at these properties are not considered to represent APECs to the Site.

## 8.1 Is a Phase 2 ESA Required?

Based on the above-noted information, a Phase Two ESA is not recommended for this Site.

## 9.0 LIMITATIONS

The information presented in this report is based on the historical data obtained from readily available public records, information provided by others and direct visual observation made by personnel with McIntosh Perry as identified herein. This assessment did not include such tasks as sample gathering, laboratory testing, or intrusive investigations. Recommendations contained within our report reflect our informed opinion based on the information gathered during our investigation. The findings cannot be extended to components of the building or portions of the Site that were not reviewed or that were concealed or unavailable for direct observation at the time of our visit.

This report describes the potential for significant negative environmental conditions being present on the property and is intended to reduce, but not necessarily eliminate, uncertainty regarding the potential for significant environmental conditions to exist on the property. Where this potential exists, the further reduction or elimination of uncertainty requires the performance of a Phase II Environmental Site Assessment (ESA), i.e., sample gathering, laboratory testing and intrusive investigation.

<u>Database Descriptions:</u> This section provides a detailed explanation for each database including: source, information available, time coverage, and acronyms used. They are listed in alphabetic order.

<u>Detail Report</u>: This is the section of the report which provides the most detail for each individual record. Records are summarized by location, starting with the project property followed by records in closest proximity.

<u>Distance:</u> The distance value is the distance between plotted points, not necessarily the distance between the sites' boundaries. All values are an approximation.


