Dear Sir,

Further to your request, Paterson Group (Paterson) conducted a Phase I Environmental Site Assessment (ESA) Update for the aforementioned property. This report updates a previous Phase I ESA titled "Phase I Environmental Site Assessment, 1104 Halton Terrace and 1150 Old Carp Road, Ottawa, Ontario" prepared by Paterson Group, dated March 18, 2019. However, this report is only updating 1104 Halton Terrace and 1150 Old Carp Road is not included in. This report is intended to meet the requirements of a Phase I ESA, as per the MECP Standard O.Reg. 153/04, as amended, under the Environmental Protection Act. This report is to be read in conjunction with the previous report.

## Site Information

The Phase I Property is currently vacant land and is located on the southwest corner of the Carp Road and Halton Terrace intersection, in the City of Ottawa, Ontario. The Phase I property is an irregular shaped lot with a footprint of approximately 8980.61 square meters in a R3X- Residential Third Density Zone. The property is generally surrounded by residential properties, with commercial properties present further east of the Phase I Property. The Phase I Property is situated in an area where adjacent lands are currently serviced by private wells and sewage systems. An updated configuration of the Phase I Property is shown on Drawing PE4576-3 - Site Plan, which is appended to this report.





## **Records Review**

### **Phase I ESA Study Area Determination**

A radius of approximately 250 m was determined to be appropriate as a Phase I ESA Study Area for this assignment. Properties outside the 250 m radius are not considered to have the potential to impact the Phase I Property, based on their separation distance.

### **First Developed Use Determination**

Based on the available aerial photographs, the Phase I Property has never been formally developed.

### **Previous Engineering Reports**

- ❑ 'Phase I Environmental Site Assessment, 1104 Halton Terrace and 1150 Old Carp Road, Ottawa, Ontario, Ottawa, Ontario', prepared by Paterson Group, dated March 18, 2019.

The original Phase I ESA was completed for a much larger tract of land that included the current Phase I Property. The Phase I ESA indicated that the Phase I Property has never been developed and was historically used as an agricultural field. Based on the findings of the Phase I ESA, no past or current environmental concerns were identified on the subject or surrounding properties. A Phase II ESA was not recommended for the subject property at that time.

### **Environment Canada**

A search of the National Pollutant Release Inventory (NPRI) was conducted electronically on November 10, 2023. The subject site and adjacent properties were not listed in the NPRI database. No records of pollutant release were listed in the database for properties located within the Phase I study area.

### **Ministry of the Environment, Conservation and Parks (MECP) Instruments**

A request was submitted to the MECP Freedom of Information (FOI) office for information with respect to certificates of approval, permits to take water, certificates of property use or any other similar MECP issued instruments for the site. At the time of issuing this report, a response had not been received from the MECP. A copy of the response will be forwarded to the client if it contains any pertinent information.

### **MECP Submissions**

A request was submitted to the MECP FOI office for information with respect to reports related to environmental conditions for the property. At the time of issuing this report, a



response had not been received from the MECP. A copy of the response will be forwarded to the client if it contains any pertinent information.

### **MECP Incident Reports**

A request was submitted to the MECP FOI office for information with respect to records concerning environmental incidents, orders, offences, spills, discharges of contaminants or inspections maintained by the MECP for the site or adjacent properties. At the time of issuing this report, a response had not been received from the MECP. A copy of the response will be forwarded to the client if it contains any pertinent information.

### **MECP Waste Management Records**

A request was submitted to the MECP FOI office for information with respect to waste management records. At the time of issuing this report, a response had not been received from the MECP. A copy of the response will be forwarded to the client if it contains any pertinent information.

### **MECP Coal Gasification Plant Inventory**

The Ontario Ministry of Environment document titled "Municipal Coal Gasification Plant Site Inventory, 1991" was reviewed to reference the locations of former plants with respect to the site. No Municipal Coal Gasification Plant Sites are located within the Phase I study area.

### **MECP Brownfields Environmental Site Registry**

A search of the MECP Brownfields Environmental Site Registry was conducted as part of this assessment for the site, neighbouring properties and the general area of the site. No Records of Site Condition (RSCs) were filed for the subject property or properties within the Phase I ESA study area.

### **Areas of Natural Significance**

A search for areas of natural significance and features within the Phase I study area was conducted on the website of the Ontario Ministry of Natural Resources (MNR) on November 10, 2023. The search did not reveal any areas of natural significance within the Phase I study area.

### **Technical Standards and Safety Authority (TSSA)**

The TSSA, Fuels Safety Branch in Toronto was contacted electronically on November 13, 2023 to inquire about current and former underground storage tanks, spills and incidents for the site and neighbouring properties. A response from the TSSA indicated that no records were listed in the TSSA registry for the Phase I Property or the adjacent properties.



## **City of Ottawa Historical Land Use Inventory (HLUI)**

A requisition form was sent to the City of Ottawa's Historical Land Use Inventory (HLUI) as part of the original 2019 Phase I-ESA that included the Phase I Property and the property addressed 1150 Old Carp Road, immediately west of the Phase I. It is not expected that a new inquiry would reveal any new information or activities on the Phase I Property or on properties within the study area, as the subject land and surrounding properties have always existed as vacant or residential lands. Therefore, an additional HLUI request was not submitted as part of this Phase I ESA Update.

The HLUI 2005 database results for 1104 Halton Terrace did not identify any activities on the site which included the current Phase I Property or on properties surrounding the Phase I Property within the study area. The HLUI Response did indicate that the Phase I Property is within the March Landfill Risk Management Area, which extends about 1.5KM from the former March Landfill (Ka-03), that operated from 1963 to 1974. The Phase I Property lies at the limit of 1.5km from the former March Landfill. According to the HLUI Response, the City of Ottawa has been managing this site since 2000 and there continues to be no evidence of any risk to public health from the landfill.

## **ERIS Database Report**

A database report, prepared by ERIS (Environmental Risk Information Services) Ltd., dated November 9, 2023, was acquired and reviewed as part of this assessment. The complete ERIS report has been included in Appendix 2.

### *On-Site Records:*

The ERIS report did not identify any relevant records pertaining to the subject site.

### *Off-Site Records:*

The off-site records identified are listed for properties which are situated at a significant distance away or are situated in an inferred down-gradient or cross-gradient orientation with respect to anticipated groundwater flow. As a result, these remaining off-site properties are not considered to pose a potential environmental concern to the subject site.

## **Aerial Photographs**

The latest aerial image in the 2019 Phase I ESA report was from 2017. A review of aerial photographs from 2021 and 2022 did not reveal any significant changes on the Phase I or surrounding properties.



## **Topographic Maps**

Topographic maps were obtained from Natural Resources Canada – The Atlas of Canada website and from the City of Ottawa website. The topographic maps indicate that the regional topography in the general area of the site slopes down in a northly direction towards Shirley's Brook. An illustration of the referenced topographic map is presented on Figure 2 – Topographic Map, appended to this report.

## **Physiographic Maps**

The Ontario Geological Survey publication 'The Physiography of Southern Ontario, Third Edition' was reviewed as a part of this assessment. According to the publication, the site is situated within the Ottawa Clay Plain physiographic region.

## **Geological Maps**

The Geological Survey of Canada website on the Urban Geology of the National Capital Area was consulted as part of this assessment. Based on this information, bedrock in the area consists of interbedded sandstone and dolomite, of the March Formation. The surficial geology in the western and eastern part of the site consists of exposed Paleozoic bedrock and offshore marine sediments, respectively, with a drift thickness ranging from 0 to 2 m, respectively.

## **Water Well Records**

A search of the MECP's website for all drilled well records within 250 m of the Phase I Property was conducted on November 10, 2023. The well record search returned eighteen (18) well records, all of which were domestic wells from the late 1960s to 2008. The wells were drilled to depths ranging from 11.5 to 75 m below the ground surface (mbgs) to fresh water. The stratigraphy in the area consisted of clay and sand; the overburden thickness ranged from 0 to 7.6 mbgs underlying limestone or sandstone bedrock.

## **Property Owner Representative Interview**

Ms. Christine McCuaig, of Q9 Planning and Design, was interviewed as part of this update. No new information was revealed about the Phase I Property as it remains undeveloped, vacant land. The Phase I Property is slated for a new residential development. Ms. McCuaig was unaware of any potential environmental concerns on the adjacent and neighbouring properties.



## **Site Reconnaissance**

Our site reconnaissance visit was conducted on November 10, 2023. Weather conditions were overcast, with a temperature of approximately  $-1^{\circ}$  C. Mr. Mohammed Ramadan from the Environmental Department of Paterson Group conducted the site inspection. In addition to the site, the uses of neighbouring properties within the Phase I Study Area were also assessed at the time of the site visit.

The site is largely vacant with some trees on the central portion. No buildings or temporary structures are on-site. Site drainage consists primarily of infiltration. The site topography appeared to be somewhat at grade with Halton Terrace and Old Carp Road. The regional topography slopes down in a north-easterly direction towards Shirley's Brook.

No underground utilities were noted on-site. No drains or private sewage systems were observed at the subject property at the time of the site visit. No evidence of current or former railway or spur lines was observed on the subject property at the time of the site visit. The surrounding properties were also observed during the site visit and are shown on Drawing PE4576-4 - Surrounding Land Use Plan.

### **Neighbouring Land Use**

Neighbouring land use in the Phase I Study Area is primarily residential or vacant, with the exception of a stormwater management pond to the east of the Phase I Property. No environmental concerns were identified with the use of neighbouring lands.

## **Review and Evaluation of Information**

### **Land Use History**

Based on the available historical records, the Phase I Property has never been developed. No potential environmental concerns were noted with the historical and current land use.

### **Potentially Contaminating Activities and Areas of Potential Environmental Concern**

No potentially contaminating activities (PCAs) were identified on the Phase I Property or within the Phase I Study Area. Therefore, no Areas of Potential Environmental Concern (APECs) were identified on the subject site.

### **Contaminants of Potential Concern**

No Contaminants of Potential Concern (CPCs) were identified on the Phase I Property.



## **Conceptual Site Model**

### **Geological and Hydrogeological Setting**

Based on the information from the Geological Survey of Canada, the overburden thickness is estimated to be in the order of 0 to 2 m, which consists of exposed Paleozoic bedrock and offshore marine sediments. Bedrock consists of interbedded sandstone and dolomite of the March Formation.

Groundwater flow is interpreted to be in a north-easterly direction towards the Shirley's Brook.

### **Existing Buildings and Structures**

There are presently no buildings or temporary structures on-site.

### **Areas of Natural Significance and Water Bodies**

No areas of natural significance or water bodies were identified on the Phase I Property or within the Phase I Study Area.

### **Drinking Water Wells**

The Phase I Property has never been developed and as such, no potable water wells are expected to be present. Eighteen (18) domestic well records were identified within the study area. It is expected that the Phase I Property will be municipally serviced, based on the proposed development and any new developments in the immediate area.

### **Neighbouring Land Use**

Neighbouring land use in the Phase I Study Area consists of vacant land, residential dwellings and some commercial retailers.

### **Potentially Contaminating Activities and Areas of Potential Environmental Concern**

As previously discussed, no potentially contaminating activities (PCAs) were identified on the Phase I Property or within the Phase I Study Area. Therefore, there are no areas of potential environmental concern on the Phase I Property.

### **Contaminants of Potential Concern**

As previously discussed, no Contaminants of Potential Concern (CPCs) were identified on the Phase I Property.





## **Assessment of Uncertainty and/or Absence of Information**

The information available for review as part of the preparation of this Phase I- ESA Update is considered to be sufficient to conclude that there are no PCAs or APECs on the Phase I Property. A variety of independent sources were consulted as part of this assessment, and as such, the conclusions of this report are not affected by uncertainty which may be present with respect to the individual sources.

## **Conclusions**

Based on the results of this Phase I ESA Update, **it is our opinion, that a Phase II Environmental Site Assessment is not required for the property.**

## **Statement of Limitations**

This Phase I - Environmental Site Assessment Update report has been prepared under the supervision of a Qualified Person in general accordance with the agreed scope-of-work and O.Reg. 153/04. The conclusions presented herein are based on information gathered from a historical review and field inspection program.

The findings of the Phase I ESA Update are based on a review of readily available geological, historical and regulatory information and a cursory review made at the time of the field assessment. The historical research relies on information supplied by others, such as local, provincial, and federal agencies and was limited within the scope-of-work, time, and budget of the project herein.

Should any conditions be encountered at the Phase I Property and/or historical information that differ from our findings, we request that we be notified immediately in order to allow for a reassessment.

This report was prepared for the sole use of Maple Leaf Custom Homes. Permission and notification from Maple Leaf Custom Homes and this firm will be required to release this report to any other party.

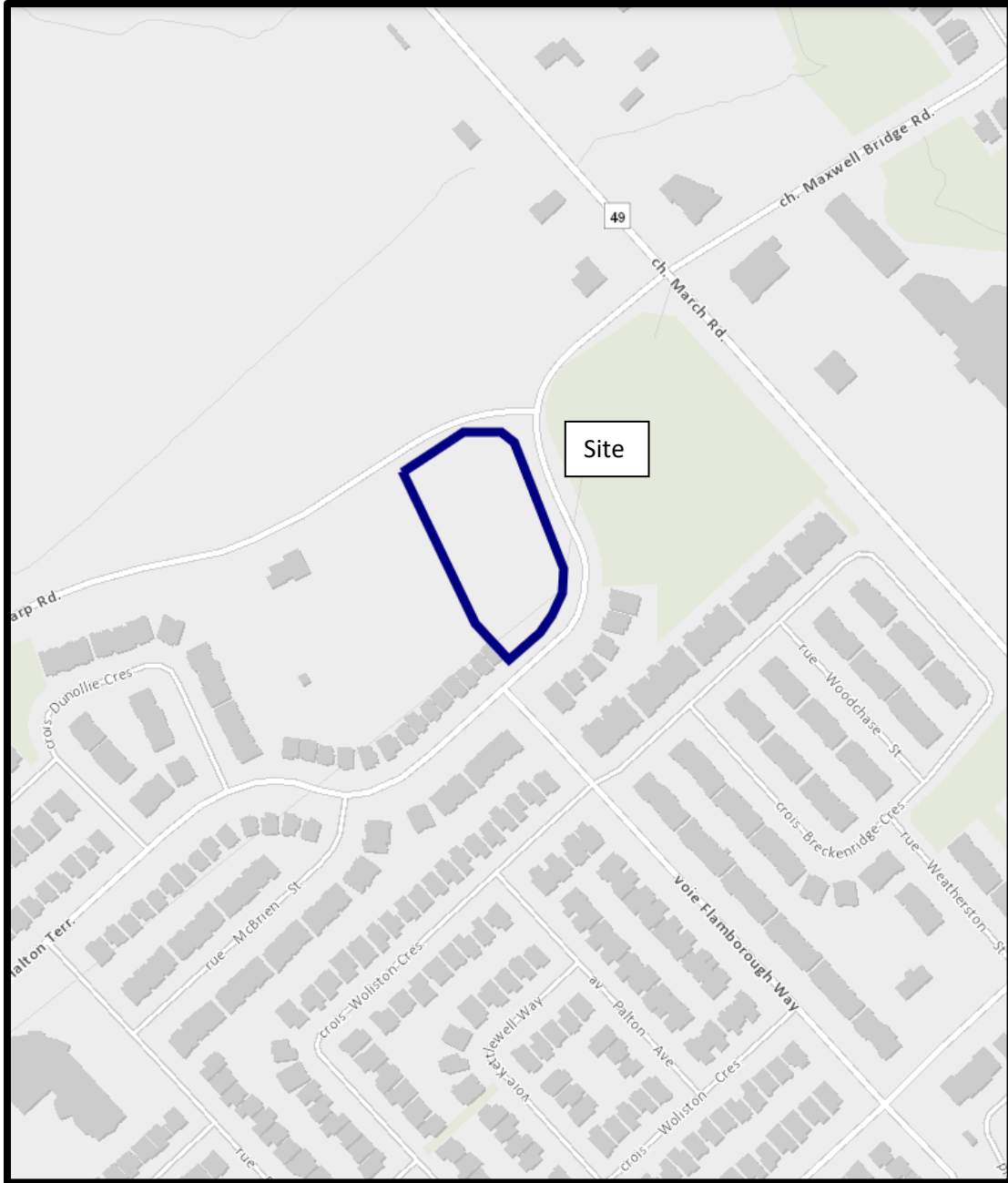

KEY PLAN

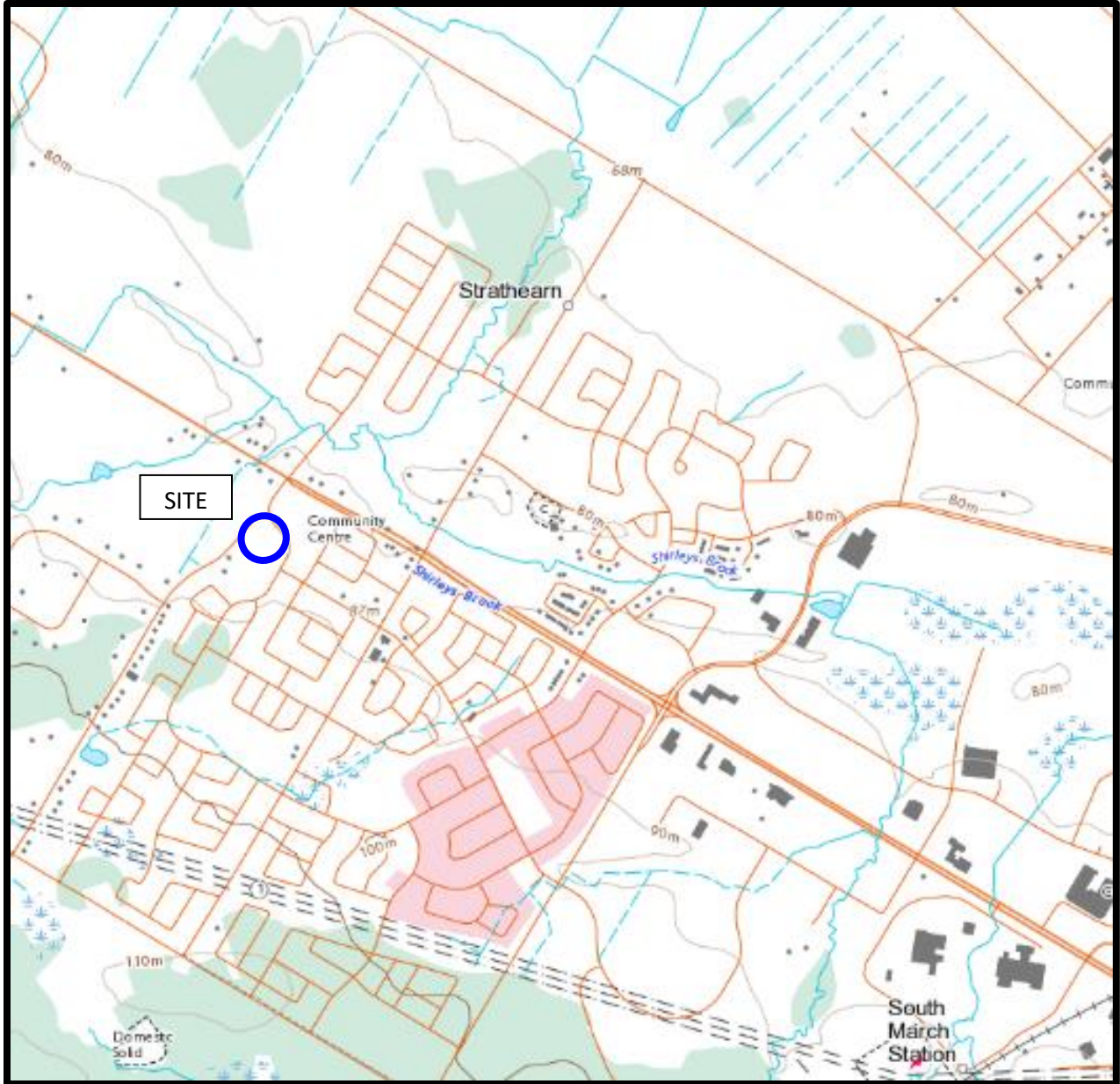
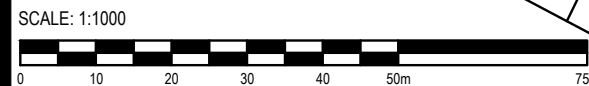
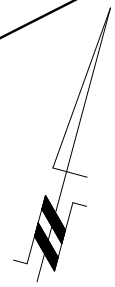
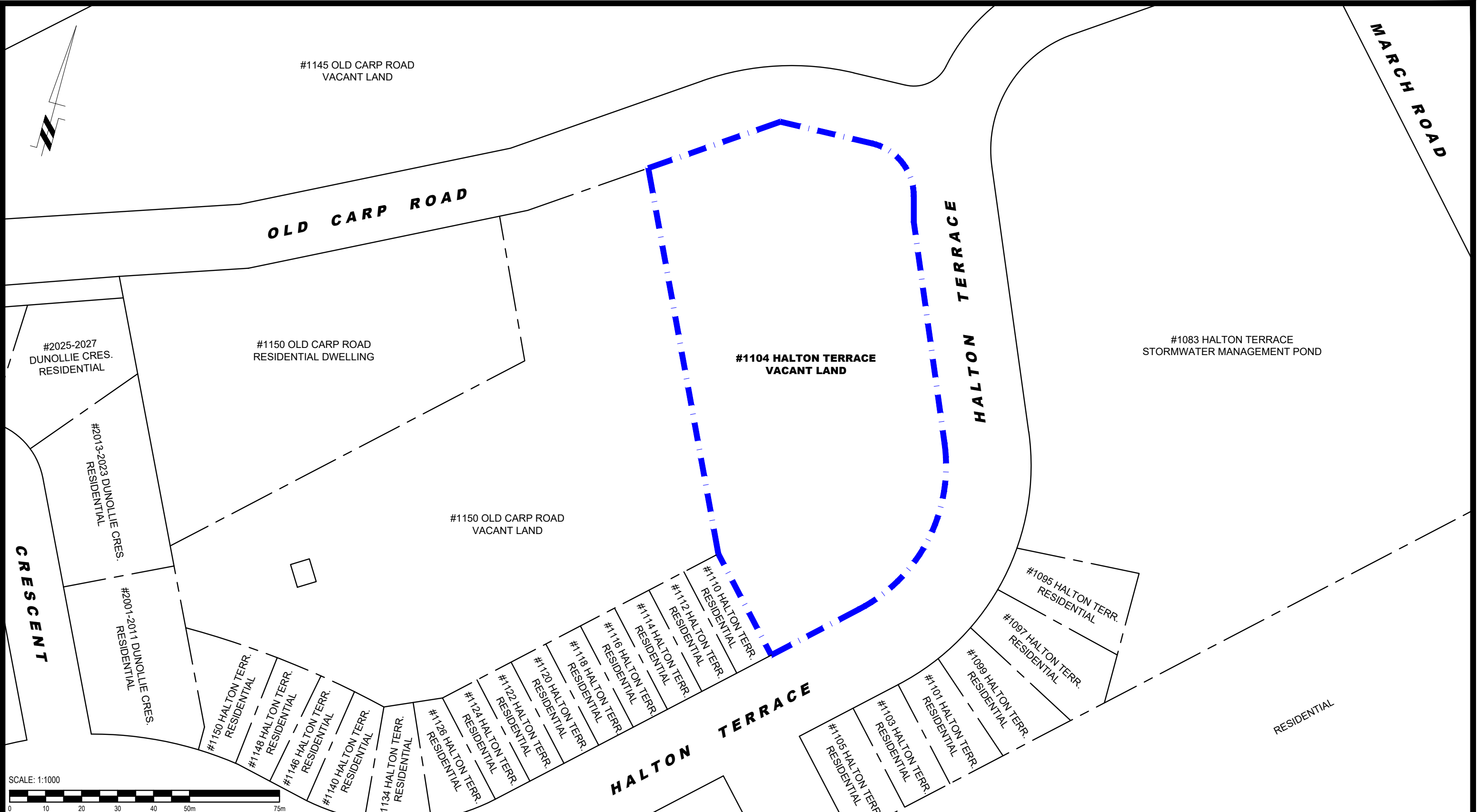


FIGURE 2

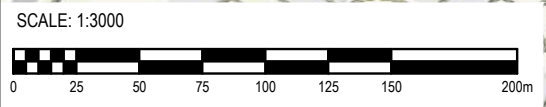

**Internal Department Circulation**

The Planning, Infrastructure and Economic Development Department has the following information in response to your request for information regarding the Subject Properties:

- The City’s Environmental Remediation Unit has no environmental records for 1150 Old Carp Road.
- The City’s Environmental Remediation Unit found that 1104 Halton Terrace is within the March Landfill Risk Management Area. There is a plume of chlorinated solvents in groundwater, which extends about 1.5KM from the former March Landfill (Ka-03), that operated from 1963 to 1974. The City of Ottawa has been managing this site since 2000 and there continues to be no evidence of any risk to public health from the landfill.
  - The Ministry of the Environment, Conservation and Parks (MECP) officially approved the Human Health Risk Assessment (HHRA) and Risk Management Plan (RMP) for the former Township of March Closed Landfill in April of 2010. The RMP measures include ongoing urban private well, surface water, groundwater, and vapour sampling programs. The City provides annual monitoring results to the MECP.
  - The RMP also included a recommendation to amend the zoning by-laws for a 293-hectare tract of land in order to restrict groundwater use in areas impacted by the former landfill. City Council approved the amendments to the various zoning by-laws on May 24, 2006. The amendments established an “overlay zone” (see attached document for details) that restricts the construction and deepening of groundwater wells for both domestic water (human consumption) and non-potable (i.e. irrigation, livestock watering, and ground source heat pumps).

A receiver of regulated waste is required to register the waste receiving facility. This database represents registered receivers of regulated wastes, identified by registration number, company name and address, and includes receivers of waste such as: landfills, incinerators, transfer stations, PCB storage sites, sludge farms and water pollution control plants. # Definitions

**Database Descriptions:** This section provides a detailed explanation for each database including: source, information available, time coverage, and acronyms used. They are listed in alphabetic order.

**Detail Report:** This is the section of the report which provides the most detail for each individual record. Records are summarized by location, starting with the project property followed by records in closest proximity.

**Distance:** The distance value is the distance between plotted points, not necessarily the distance between the sites' boundaries. All values are an approximation.

**Direction:** The direction value is the compass direction of the site in respect to the project property and/or center point of the report.

**Elevation:** The elevation value is taken from the location at which the records for the site address have been plotted. All values are an approximation. Source: Google Elevation API.

**Executive Summary:** This portion of the report is divided into 3 sections:

'Report Summary'- Displays a chart indicating how many records fall on the project property and, within the report search radii.

'Site Report Summary'-Project Property'- This section lists all the records which fall on the project property. For more details, see the 'Detail Report' section.

'Site Report Summary-Surrounding Properties'- This section summarizes all records on adjacent properties, listing them in order of proximity from the project property. For more details, see the 'Detail Report' section.

**Map Key:** The map key number is assigned according to closest proximity from the project property. Map Key numbers always start at #1. The project property will always have a map key of '1' if records are available. If there is a number in brackets beside the main number, this will indicate the number of records on that specific property. If there is no number in brackets, there is only one record for that property.

The symbol and colour used indicates 'elevation': the red inverted triangle will dictate 'ERIS Sites with Lower Elevation', the yellow triangle will dictate 'ERIS Sites with Higher Elevation' and the orange square will dictate 'ERIS Sites with Same Elevation.'

**Unplottables:** These are records that could not be mapped due to various reasons, including limited geographic information. These records may or may not be in your study area, and are included as reference.
