1.0 Introduction

The subject of this Heritage Act Acknowledgement Report is 231 Buena Vista Dr., Ottawa, ON. The Property is privately owned. The campus is occupied by several buildings all belonging to Elmwood School. The Elmwood Senior School building, the subject of this addition project, dates from the 1920s. The property is designated under Part V of the Ontario Heritage Act, and located in the Rockliffe Park Heritage Conservation District, but is not individually designated.

1.1 Purpose of this Report

This Heritage Act Acknowledgement Report for 261 Buena Vista Dr. is a submission requirement of the City of Ottawa to demonstrate that the applicant has satisfied the applicable Ontario Heritage Act requirements. It is the City's practice that applications under the Ontario Heritage Act and the Planning Act be considered concurrently. The purpose of this report is for the applicant to demonstrate they are meeting the requirements under the Ontario Heritage Act, where such a property is under the jurisdiction of the Ontario Heritage Act.¹
