**SITE DESCRIPTION:**

THE SITE IS OF MODERATE ENVIRONMENTAL VALUE, DUE TO THE HEALTH AND SPECIES OF THE TREES INVENTORIED. THERE ARE 42 TREES LOCATED ON PRIVATE PROPERTY, AND 38 LOCATED ON THE ADJACENT PROPERTIES AND WITHIN THE ROW. OUT OF THE 80 TREES THAT HAVE BEEN INVENTORIED 28 ARE DISTINCTIVE TREES (COMBINED DBH OVER 50cm), 5 OF WHICH ARE SILVER MAPLES ALONG THE SOUTHERN PROPERTY LIMIT WITHIN THE FUTURE CITY OF OTTAWA PARKLAND. THE MAJORITY OF THE TREES (#10-29) LOCATED ALONG RIVERSIDE ARE IN POOR CONDITION AND HAVE BEEN SEVERELY PRUNED DUE TO THE OVERHEAD WIRES. TREE #32 LOCATED ON THE ADJACENT PROPERTY TO THE NORTH IS LEANING SEVERELY ONTO THE PROPERTY AS NOTED AND WILL NEED TO BE PRUNED. TREES #49-53 HAVE BEEN RECOMMENDED FOR TRANSPLANT. THERE IS NO NATURALLY OCCURRING SURFACE WATER, AND NO STEEP SLOPES ON THE SITE.

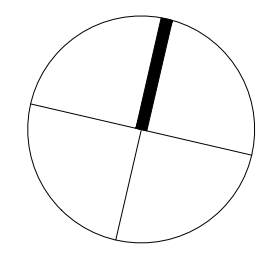
